Snow Days...

Friday's snow reminded me of growing up back east and the anticipation that accompanied any snowstorm. That of course, was getting a "Snow Day" off from school. But times have changed from when I was a kid way back when.

Our four to five inches of white stuff wouldn't have qualified as a snow day back then, as it didn't in District 60 last week either. But as I said, times have changed and the East's snow mentality is different than Pueblo.

First, we started with 180 school days, versus today's 175 "student contact" days as they are now called. There was a five day buffer built in for weather events, which along the coast, could have included hurricanes as well. We'll leave the rest of the calendar discussion to Part Two.

Second, the East's mentality was that roads got plowed. To actually get a snow day, there would have been a substantial amount

of snow and not enough time for the various towns to clear all the roads.

But probably the biggest difference is that I went to school prior to the open enrollment policy we have now. Pretty simply put, you went to the closest schools to your house and if it was over a reasonable distance away, the schools provided bus transportation. This meant that there weren't thousands of extra vehicle trips on the road shuttling kids to school across town every day. Nor were there traffic jams in front of the schools. Anyone here who makes their morning commute between 7:30 and 8:30 am can easily see the difference in traffic between a school day and a non-school day. Not to mention in bad weather there's even more traffic as parents take kids to school that would normally have walked.

So my point is that maybe we should consider padding a few extra snow days into our school

schedule. If you don't use them, take them off at the end of the year; a fact that you would know three months in advance. There's no need to create extra traffic on snow days.


