Good Deal!

It was revealed last week that the City of Pueblo will spend around eleven million dollars to bring the Air Force Pilot Training school here to Pueblo. While this sounds like a lot of money, the school is destined to be here for at least ten years and will bring almost two hundred jobs to the industrial park. In addition, the students will be bringing more money into Pueblo's economy and the City will collect lease money from the operator of the school.

As I said before, this was a job well done by PEDCO and the City and a good use of our half-cent sales tax money.

And about economic development...

This year, the half-cent sales tax for economic development will come up for renewal with the voters. Right now there are discussions going on about how that tax will be used in the future. One idea being discussed is that some of the money be

put towards education and training to develop a better workforce.

As you know, I'm a real fan of increasing educational opportunities here in Pueblo and I do believe it is reasonable to use economic development funds for that purpose. After all, if we have a better-prepared workforce, we should have more success in bringing in new companies.

Some of you may believe that I'd like to see a large chunk of that money be put towards education. Well, surprise, surprise! I do want to see some of the money put towards training and education, but I believe it is more important that we continue to bring in good jobs to the area. We need to put those funds towards improving the quality of jobs here in Pueblo.

I grew up in a very mixed area where jobs ranged from blue collar to professional. My own dad transitioned from an ironworker to an office worker while I was in junior high. The

kids I went to school with had a first-hand look at the opportunities available to them if they did well in school. This greatly improved their reasonable expectations for success after school. As I look back on my graduating class, there were kids from the lowest economic scale who went on to be doctors, lawyers, and veterinarians.

Now while economics in itself doesn't instill greatness, it does provide one important aspect: hope. While we still need an excellent educational system, we also need our kids to see a good chance for a good job in the future.

So we need to keep PEDCO going but don't think I'm going to let them off easy in the future either!

60 million voters surely can't be this wrong ... or can they?

Astoundingly, in just one decade, the Republican Congress has achieved a depth of depravity and corruption greater than the Democrats were able to tally up during over 70 years of control prior to the 1994 GOP takeover.

Of course, what I call corruption (such as members of Congress and their lobbyist buddies surreptitiously giving \$57 billion in pork barrel graft to themselves, their companies, and their districts, at a time when they and the President are cutting taxes AND spending like drunken sailors on ill-advised military adventurism) ... as I say, corruption like this appears to be quite acceptable to the 60 million Americans who put and keep these malefactors in office.

Among these 60 million voters are some 11 million "social conservatives." These are, generally speaking, economically comfortable rural folks, especially women, in agriculture and other family businesses, who identify themselves as born-again Christians. These folks openly witness that they believe the President is also a born-again Christian and believe his assertion that he consults his God and Savior prayerfully before making Presidential decisions. They are therefore convinced that even his decisions to commit acts of extreme violence are sanctioned by their God — even those which result in tens of thousands of brutal deaths and 100's of thousands of maimings, such as in Iraq and Afghanistan. Much of this is glossed over and referenced glibly as a foundation for Traditional Values

But these folks are only one manipulated factor in the Republican Party's hold on power. The real power is generated and sustained by the machinations of the international financial and business interests which have woven



an impenetrable web of the various single-issue factions into the party. Everything from abortion to Manifest Destiny, from elimination of taxation to the destruction of public education ... all these and 100's more issues, such as chlorine in drinking water and undocumented Mexicans in the workforce ... all are combined with a glue of blind "God-loves-America-most" dogma which will continue to set the political trend for the foreseeable future.

Is George all hot air on hydrocarbons?

We revisit last week's speculation that the U.S. might be secretly developing technologies to replace hydrocarbons as an energy source. As I said, the average American has no way of knowing, so we must assume such a program does not exist. If it did, and if we were encouraging Third World oil-producers to drain the last drop of oil from under their lands, it would be a tragic waste of Earth's hydrocarbons which might be needed 100 or 1,000 years from now.

So I joined those who are suggesting that to fight global warming and/or to guarantee our national security, we should go on a petroleum diet, now. I listed a few proposals which have been ignored for some 30 years. Among them:

- We should tighten EPA emissions standards, now.
- We should provide incentives to the entire population to use bicycles, alternative-power, and small-engine vehicles.
- We should ration gasoline, now.
- To this list should be added the construction of perhaps as many as 500 nuclear power plants over the next decade. As I mentioned in a recent column, nuclear is a radio-active mess, but every other power source which is being or may also be implemented will present excruciating problems, too.

To fight climate change and to disarm our antagonists, we must get off petroleum and other hydrocarbons. As to

climate change, there is no doubt that its impact will be far more horrendous than today's terrorists.

And those terrorists and every country in the Muslim world except Indonesia are being bankrolled by us as we pay premium prices for their crude oil. All this money, like oxygen, feeds the fires of cruelty, oppression, superstition, and ignorance against which we then must pit our military. Solution: *cut off the money and starve the fire*. Think about it: every barrel of oil we don't need to buy reduces total demand ... and that exerts downward pressure on the market.

The snake that bit us all:

Two *New York Times* defense correspondents — Michael Gordon and Ret. Marine Maj. Gen. Bernard Trainor — have put together an analysis of George Bush's Iraq attack and occupation. Titled *Cobra II*, the paperback details all the obvious, stupid mistakes the Bush Administration made regarding Iraq, plus many errors of judgment based on hubris, incompetence, and White House paranoia.

No need to go over the details. You read about virtually all the little tragedies of this catastrophic foreign policy error in this column starting over two years ago.

Additionally, Bushy has presided over a national government which has, in obvious instances, been mismanaged: FEMA, the FDA, the FCC, the Pentagon, Education, and Interior, to name a few.

However, his main claim to fame is a national budget out of control. George is now responsible for the highest national debt as a ratio of GDP since Ronald Reagan. He also allowed the Trade Deficit to hit an annual total, last year, of \$864 billion.

George has no guts. He has yet to veto any new bill from Congress. He has yet to fire any of his cronies (such as Defense Secy. Rumsfeld) for their incompetence. He is

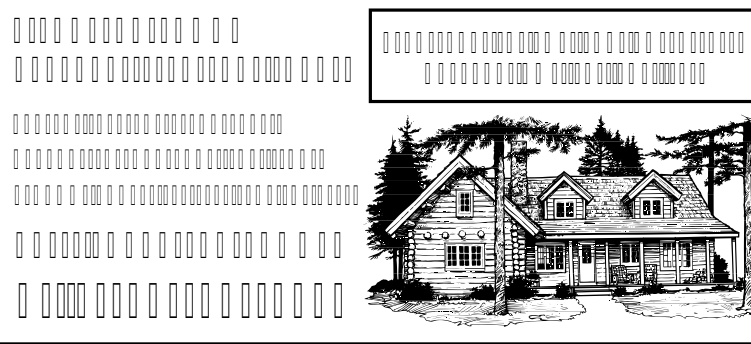
