Unlimited Executive Power?

News that the National Security Agency has secretly been collecting phone-call data from millions of Americans has spread far and wide, but that isn't the half of it. In the op-ed below, Cato Institute legal scholars Gene Healy and Timothy Lynch argue that the current exaggerated claims that the Bush administration is making about its constitutional executive powers during the war on terror will have far-reaching and rather horrible consequences.

Since 9/11, they explain, the Bush administration has single-mindedly advanced the view that in time of war, the

president is the law, and no statute, no constitutional barrier, no other branch of the United States government can stand in his way when, by his lights, he is acting to preserve national security.

Faith-Based Constitutionalism

National Security Agency has secretly been collecting phone-call data from millions of Americans comes on the heels of Attorney General Gonzales's suggestion that the president may have "inherent executive authority" to wiretap Americans' domestic calls without a warrant. That was only the latest in a series of extraordinary constitutional claims the Bush administration has made during the war on terror. Among those claims: the authority to lock up American citizens on American soil and hold them without charges or trial for the duration of the war on terror and the power to bypass validly enacted statutes that interfere with any tactics the president wants to pursue in the war on terror. Behind all of these claims lies a common principle: presidential power must be left unrestrained, checked only by the good faith of the executive and the remote possibility of impeachment.

What's surprising is that even as the president has been hemorrhaging conservative support on issues such as immigration and spending, conservatives continue to back the president's dubious constitutional claims. The Right has long celebrated Hamiltonian "energy in the executive," but the president's broad theory of executive power goes far beyond that. It borders on James Madison's nightmare, in which legislative, executive, and judicial powers are concentrated in the same hands, a state Madison termed "the very definition of tyranny."

The recent revelation that the | veillance, the Wall Street Journal's | sight and lock them up without editorialists wrote: "Let's hope that the next time some Beltway potentate bemoans the 'Imperial Presidency,' everyone starts hooting with laughter. What we're watching this week is the Lilliputians on Capitol Hill tying down a Bush Administration that increasingly looks like Gulliver."

A month later Gulliver's attorney general, testifying before Congress, advanced the administration's theory of inherent executive authority to conduct warrantless surveillance of Americans' domestic phone calls, while refusing to confirm or deny the existence of any such program. That day, the Justice Department issued what might be termed a "nonclarification clarification" of Gonzales's testimony: "The attorney general's comments today should not be interpreted to suggest the existence or nonexistence of a domestic program.'

Conservatives trust George W. Bush not to abuse the vast powers he claims. But only a few years ago, they recognized that not every president was worthy of unconditional trust. They recognized that the presidency can be captured by exceptionally venal, corrupt men who would stop at nothing to retain power. Fairly or unfairly, they saw President Clinton as such a man, and denounced him in lurid terms. Conservatives, including the Journal's editorialists, railed against misuse of hundreds of FBI files and the alleged abuses of FBI powers during the Travelgate scandal. Even now with another candidate named Clinton leading the polls for the Democratic nominatempts to cabin President Bush's power. At the annual meeting of the Conservative Political Action Committee back in February, former congressman Bob Barr, a hard-core conservative and a former impeachment manager in the effort to remove President Clinton, got a notably cool reception when he warned about the dangers of an increasingly imperial presidency. His opponent in the debate, Viet Dinh, the architect of the PATRIOT Act, was more of a crowd-pleaser. Dinh told the audience, "The conservative movement has a healthy skepticism of governmental power, but at times, unfortunately, that healthy skepticism needs to yield."

"At times" might more accurately be recast as "from now on." The Pentagon has taken to calling the fight against terrorism "The Long War." Unlike other wars, this one will not end with a peace treaty across a diplomat's table. It will take decades, and when victory is achieved, we may not know with any certainty that we've won. The extraconstitutional powers we tolerate now will be available for all future presidents, scrupulous or otherwise. And our entire constitutional system repudiates the notion that electing good men is a sufficient check on abuse of power. To preserve that system, this country sorely needs a resurgence of conservatives' "healthy skepticism."



Solar bike wins again, gets 2050 mpg equivalent

Optibike 5/26 – University of Colorado student Craig Weakley is no stranger to the victory podium at the Tour De Sol. For two years running, Team Optibike, led by CU/Boulder student Craig Weakley, has dominated the Tour De Sol, the worlds largest "green" transportation show and competition. Competing for efficiency and performance in several events against

Team Optibike is not a hybrid car or a biodiesel, it's an electric bicycle. In the 16 year history of the Tour De Sol, 2006 was the first year an electric bicycle team even asked to race against the hybrid cars. "We [Optibike] wanted to dem-

Haldau'a

onstrate how an electric bicycle is an alternative to an automobile and is infinitely more efficient than even a hybrid car. I rode 103 miles in 4 hours in the pouring rain across upstate New York and only used about \$0.15 worth of wind generated electricity", said rider Craig Weakley.

The New York State Dept. of Motor Vehicles was not as excited at first about the new technology. "I have never seen anything like it", said NYS DMV Tech Mark Engle, who eventually granted Team Optibike Experimental Vehicle Status because ancient laws in New York State prohibit power assist electric bicycles from operating on the road. Such vehicles are legal in Colorado and 43 other states and require no license, registration, or insurance.

Typically, electric bicycles enter the "Neighborhood Electric Vehicle" competition which is held in a large parking lot and is representative of an "urban style course." The day after riding 103 miles in the rain, Craig defended the Optibike title in that event as well completing 114 (.75 mile) laps in 3 hours. The farthest Craig had ridden on a bike prior to the event was about 8 miles.

Optibike, LLC manufacturers High Performance Electric Bicycles in Boulder, Co in a 100% wind powered facility using custom parts primarily made in Colorado and the West. 2006 is the first full scale production year for Optibike and 125 hand built bikes are set to be deliv-

ered this year to a waiting list of customers. Craig and Optibikes' founder, Jim Turner have spent the last year educating the public about electric bicycles and their capabilities for commuters. Hill climb? Pikes Peak in 1:30:00. Rain? Range? 103 miles in 4 hours (9.5 inches of rain fell in that time) on a single charge at the Tour De Sol.

Two other Boulder Companies have teamed up with Optibike to spread the word about cheap, clean, and healthy commuting/transportation. Wild Oats and Clean and Green Community Based Wind Power. Clean and Green provided enough Renewable Energy Credits to offset the 14552 lbs of CO2 that was generated by the team traveling to New York and racing in the event.

"Wild Oats Markets supports Optibike in their vision to create clean, healthy communities by reducing air pollution and increasing personal activity levels in a unique and innovative way. At Wild Oats it has always been a part of our mission to reduce our negative impact on the environment, so our partnership with Optibike and Clean and Green is a natural fit", said Boulder Wild Oats Marketing Manager Susan Thompson.
