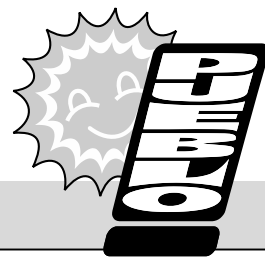

In this Tribune, we're reprinting a breakdown of petroleum use provided by the U.S. Petroleum Institute. It was downloaded back in April 2004, but the basic info is virtually the same today.

However, back in 2004 the price of crude was considerably less than today. At \$70 per barrel, \$700 million is paid out every day...and that's wholesale. At around \$2.60 a gallon (figuring roughly \$3.00 less excise taxes), the 19.4 gallons of gasoline derived from a barrel of crude puts \$50.40 in the producer's till.

Diesel fuel is pretty pricey, too. So, the 9.7 gallons of diesel from a barrel of crude probably generates about \$25.00 for the producer.

Over 4 gallons of jet fuel comes from each barrel of crude, too, but I can only guess at its price. At \$2.00 a gallon, it would yield \$9.00 for the producer.

The total product from a barrel of crude that we can trace to ground and air transportation appears to total about 33.4 gallons. And the retail revenue (without taxes) is probably about \$84.40.

Since, as the Petroleum Institute points out, a 42-gallon barrel of crude yields 44.6 gallons of products, we burn over 75 percent of all petroleum for transportation purposes.

Another bit of trivia: in Colorado, the total fuel tax for gas is 40.4 cents per gallon, and for diesel, it's 44.9 cents a gallon. So, every gallon of gas we purchase automatically pays for the building and maintenance of the state and federal highways we need to get anywhere.

Ten years ago, California prevailed upon all the automakers to come up with an electric car. What they came up with could not be purchased, only leased. Many folks who leased them liked them but, when the lease was up, every one was taken back and destroyed.

Electricity doesn't "grow on trees" but it can be produced without petroleum to drive the generators. Coal, nuclear, wind, hydro, natural gas, solar, and thermal are alternatives.

Nothing moves in America without petroleum. That is our Achilles' heel. That is the reason for Middle Eastern terrorism, which is pretty much all terrorism. Trouble in Afghanistan, in Iraq, in Iran, in Indonesia, in South America, and in Somalia all spring from the industrial world's insatiable thirst for crude oil.

Because of that, American individuals and businesses lay out \$844 million every day for crude oil products from that part of the world which exists in a primitive, pre-industrial state. In a year, that amounts to at least \$306 billion going out of our pockets and into the pockets of thugs who rule those parts of the world which they intend to keep in a Dark Age state of development.

Add to that some \$450 billion just to maintain our defense department in a "no combat" state. Then add about \$100 billion for each of the three years we have deployed our military in Iraq. Then add the \$2 trillion it is estimated it will cost to care for the 60,000 of our military who have been wounded, many for the rest of their crippled lives.

It is obvious that we could easily afford to pay twice as much for an alternative fuel to power our vehicles. Check it out:

- We're paying \$306 billion a year for imported petroleum transportation products;
• Plus \$204 billion a year for domestic petroleum transportation products, which totals
• \$510 billion.
• Since the \$450 billion we put into Defense each year is supposed to prepare us to fight two wars at a time (what a cruel joke), let's just charge half of our preparedness infrastructure to the Iraq invasion and occupation, or \$225 billion.

• Plus, of course, the \$100 billion appropriated each year to actually have our military in Iraq.

It looks like this:

- \$306 billion for foreign oil fuel
\$204 billion for domestic oil fuel
\$225 billion to be ready to fight one war
\$100 billion to actually fight in the Middle East
Subtotal: \$835 billion

• Plus the \$2 trillion (and counting) estimated cost of taking care of our wounded, many for the rest of their lives. That's \$667 billion for each of the three years we've been in Iraq.

Total: \$1.5 trillion annual cost to depend exclusively on crude oil for our air, ground, and sea transportation.

So ... let's face it: the car makers and oil men got us hung up on petroleum and now we have to pay the huge hidden costs. Our bill for foreign oil products to keep our vehicles going is not \$2.60 a gallon. For that 122 billion gallons we burn annually we are probably paying a little over \$12.00 a gallon (\$1.5 trillion divided by 122 billion gallons). Happy motoring!
