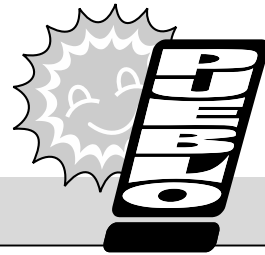

Rithmetic and Pueblo...Follow-up

Originally, this column was going to be another one on the immigration issue but I've decided that issue is more a distraction from other world events and the high price of oil. Also, since my column last week, I've had conversations with several educators who totally agree with my view of our math problems.

One of those people neatly pinned down the situation by saying that we need to teach arithmetic in grades kindergarten through fourth. Then we can start teaching 'math'. This is exactly what most of us in the 'older generation' were taught. What that means is that you teach addition, subtraction, multiplication, and division in the early primary grades. Shampoo, rinse, and repeat, and repeat, and repeat until the kids know this by heart. Don't mix in silliness like stem and leaf plots, estimate and check calculations, and inane classes and subclasses of numbers. Stem and leaf plots, a basic form of distribution analysis, is great for statistics and probability, but has no place outside of high school or college. Estimation is admittedly important, but is much easier once you've mastered the four basic arithmetic functions. And those classes and subclasses of numbers are completely

useless information, unless you're going on to study theoretical math. Teaching irrational numbers to pre high school students is, well, irrational!

Why is all this important? Easy, if you don't know arithmetic, you can't learn fractions. If you can't do fractions, you can't do algebra. If you can't do algebra, you'll suffer doing geometry and trig. So if you haven't mastered arithmetic, you're out of luck when it comes to the rest of math. Even courses like applied math and practical geometry require that you know arithmetic.

Now many will say "my kid is bored learning arithmetic." Too bad, so sad. There are plenty of other opportunities for kids to learn challenging things, and if your child is an Einstein they should have no problem using their imagination to capitalize on those opportunities.

If we're looking for a curriculum, I think I still have some workbooks my mom saved from the early 60's!

Let's use the CSAPs for middle school advancement criteria!

Heck, let's use them for the grading system too. While we're at it, let's use them for placement tests. Why not? We've already changed the school calendar so we have more time before the CSAPs. We already "teach for the test." It works out great! We don't need any textbooks or a curriculum. We can just staple together all the previous tests and

presto, we're done.

At first glance, one might think the district office has a psychotropic drug problem. But in actuality, they just suffer from using bad math; the random try theory. That is when you approach solving a problem by 'trying' random solutions rather than analysis. Basically, it's akin to a mechanic replacing parts in your car until they fix the problem.

Just like the mechanic, it's a costly fix. The cost here won't be monetary, it will be how many kids are damaged or completely lost. Unlike the mechanic, the damage done here may be irreversible.

I truly hope that Dr. Covington will bury the shotgun approach for a while and instead develop a comprehensive, well thought out plan for our kids' success. If the shotgun approach is the best we can come up with, then "we" aren't doing our jobs. Take it from one who knows firsthand; good grades, applying oneself, and maximizing your potential is far more important in life than being able to ace a standardized test.
