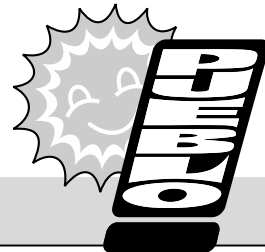

No Wonder kids are confused with math...

By now, you all know how I feel about the new D60 school calendar that has school starting next Monday instead of after Labor Day.

Yesterday, I received the new "regular" daily schedule for South HS. I have to print it here just to show the convoluted logic used in this simplified schedule.

- 1st. Period 7:30 - 8:20
- 2nd Period 8:25 - 9:15
- 3rd Period 9:20 - 10:20 (Last 10min Channel 1 news??)
- 4th Period 10:25 - 11:25 (Last 10min SHS news??)
- Lunch 1 11:25 - 12:05
- 1st 5th hour 11:30 - 12:20
- Lunch 2 12:20 - 1:00
- 2nd 5th Hour 12:05 - 1:00
- 6th Period 1:00 - 1:50
- 7th Period 1:55 - 2:45

When I went to school, way back when, we had eight periods, 50 minutes each, with five minutes between classes. Oddly, this works out to the very same seven hours and fifteen minutes of the above schedule. Rather than worrying about reducing lunch to 30 minutes and having 20 minutes elsewhere for news, lunch was one of the two middle periods. We didn't get news, except for a few times a week in

homeroom. Life must be much busier if the kids need 100 minutes of news each week!

And this doesn't touch on the infamous "Late Start" Wednesday schedule nor the "Assembly" schedule. I'm all in favor of staff development, but rather than wasting an hour and a half a week on a late start, let's take that 50 hours a year and provide substitutes so teachers can attend valuable staff development activities. There are many such seminars done throughout the year and teachers have to use their time and arrange subs if they want to attend.

Speaking of Subs...

Substitute teaches are paid on a par with retail clerks here in Pueblo. I take that back; you can make more money working at Safeway than you can as a sub. But don't look too far for whom to blame on this one. It's our own fault. The fact is that the district doesn't have the money to pay subs more, as it doesn't have the money to keep up on capital improvements. Yep, we gave them \$98 million dollars for improvements but the problem is they needed two and a half times that amount.

Why's it our fault? Two reasons. One, we voted for the stupid TABOR amendment. I call it stupid because I can't print the

real words I'd like to use. TABOR, like most ballot initiatives, was a piece of trash. The problem is that most of us read only the title or the summary paragraph and what the heck, it looked like a good idea. But the devil is in the details, as they say, and the details in TABOR stunk. If we have the intelligence we think we do, we should have exempted education funding from TABOR.

Second, we opt to use lottery money for foo-foo parks and stuff, rather than for education, as many states do. So I guess our priorities are hunting, fishing, and pretty little greenbelts in rich mountain towns rather than education.

On the one hand, we look to save money with TABOR; on the other we look to fund pork-barrel projects with lottery money. Maybe we're just not as smart as I think we are.

Or maybe we just don't want our kids to be smarter than us? I think that too often we forget that the kids are the victims in our own petty battles.

When Mike gets perturbed...

I love it when Mike Colucci winds up and hits a home run. His comments this week are candid and "on the mark." How long will Colorado fund education as if it were some kind of punishment of our children? To paraphrase a line that's going around lately:

Our support of TABOR proves we hate taxes more than we love our children.

*The line being used by political types, in reference to the terrorist tactics supported by many in the Middle East, is: "They hate Israel more than they love their children."

Fascist Islamists... maybe

The President has a new label for his enemies. On Wednesday, he described the forces aligned against the West, and the U.S. and the U.K. in particular, as "Islamic Fascists." There is historical evidence that Nazi Germany had some success currying favor with certain Middle Eastern religious leaders who were especially angered by the oppressive tactics of the Colonial Powers (mostly Britain and France) and the U.S. prior to World War II.

But it's a big stretch to put the word "Islam" together with the word "Fascist." Fascism is generally seen as the system of government adapted in both Germany and Italy during the years leading up to World War II. Its main features were intended to control and coordinate the business and industry of a country with the goal of greatest efficiency and equity.

The tools employed were trade unions and business syndicates, which were "licensed" by the central power. Private property was permitted but its use dictated by the central authority.

Because such a system depends upon one party control, it was corrupted from the outset by Hitler and eventually also by Mussolini. Hitler played an elite circle of his associates against one another, so as to keep the real decision-making to himself.

Reminiscent of the way Hitler took over Germany from within is the way Heshollah has gradually imposed its militant power on Lebanon. But Hitler had no foreign backers, whereas Heshollah is financed by Iran and is free to train its military and transport arms in and through Syria, right next door.

Perhaps it is possible to define Iran's religious dictatorship as fascist, but we think it's a pretty big stretch. Perhaps what we are witnessing is just a fuzzy War of Words to match the muddle of our strategic efforts.
