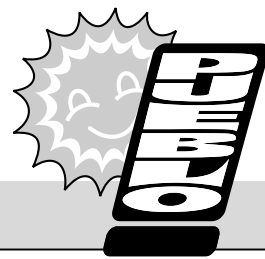

## Rating down despite foiled terror plot and Lebanon cease fire

### Zogby: Bush job approval at 34 percent

Zogby 8/19 -- President Bush's job approval rating dipped two points in the last three weeks, despite the foiling of an airline terror plot and the adoption of a cease-fire deal between Israel and Hezbollah forces in Lebanon, a new Zogby International telephone poll shows.

The survey was conducted August 11-15, 2006, included 1,018 respondents, and carries a margin of error of +/- 3.1 percentage points.

The numbers continue to reflect erosion in the President's political base — with 62 percent of Republicans giving him positive marks for his job performance, while 38 percent give him negative marks. Even among weekly WalMart shoppers — a demographic group identified by Pollster John Zogby as a critical support group for Bush — just 45 percent now give him positive job marks, though his numbers

among those shoppers have improved 10 points since early June.

More than three out of four — 76 percent — of weekly WalMart shoppers voted for Bush over Democrat John Kerry in the 2004 presidential election, earlier Zogby polling showed.

Among both conservatives and those who consider themselves very conservative, 59 percent give him positive marks, while 41 percent in each group gave him a negative job rating.

One third of respondents — 34 percent — said that, overall, the nation is headed in the right direction, while 59 percent said they think things are off on the wrong track.

Pollster John Zogby: "President Bush's numbers mainly reflect the country's thinking on the war in Iraq, and most people have made up their minds that the war overall has not been worth the loss of American lives. Terrorism is an im-

portant issue to Americans, but when it comes to judging Bush's presidency, their decision is based largely on Iraq."

Democrats continue to carry a lead into the fall campaign season on the generic congressional election question. Likely voters in the poll, asked whether they planned to vote for the Democrat or the Republican in their local congressional election, 39 percent favored Democrats, while 31 percent said they would be voting for the Republican candidate. Democrats also are winning the battle among independents, who favor the out-of-power party by a 32 percent to 20 percent margin, with 41 percent of independents yet undecided.

Asked if the war in Iraq has been worth the loss of American lives, 38 percent said "yes," while 56 percent said "no," a ratio that has held steady over the past year or so, the pollster reports.

**Name calling assures base when policies fail**

George and his GOP party members carefully follow name-calling guidelines handed down by the PR-minded folks over at Grover Norquist's *Americans for Tax Reform*, assistants to the party's chief conservative dirty trickster, Carl Rove. For instance, they give inheritance taxes the tag, "death taxes." Any notion of rethinking our policy in Iraq is called "cut and run." Any government official or member of Congress who urges that some program be beefed up is labeled a "bleeding heart, tax-and-spend liberal." A judge who rules against George's power grabs is said to be "legislating from the bench."

The GOPs and Norquist have drawn this name calling from the rivalry tussles of a grade school playground. They work at this 9-year-old's intellectual level because they know their political base is made up mostly of adults who think that way. This play to the simpler thinker has met with great success. Folks who resent compound sentences and 3-syllable words eat up this name calling, because it invariably gets its punch from the intellectual capacities displayed during 4th grade recess.

This strategy gives the GOP a stranglehold on its rough-cut base. And those folks can be stirred up by almost anything they think isn't the way it was in the good ol' days.
