State Ballot issues - Part III!

Last week, I went 0 for 7 on the state ballot issues. Here's my take on the other seven, the referendums. There are two that are worthy of some discussion; I'll breeze through the others.

Referendum E - Property Tax Reduction for Disabled Veterans

Admittedly, this one doesn't sound like a bad idea. Once again, though, I can't see that the Colorado Constitution is the place for tax breaks. So, this one gets a no as well.

Referendum F - Recall Deadlines

As I've said before, we don't need more poorly written gobbledy-gook in the Constitution. Just say No #9

Referendum G - Repeal of Obsolete Provisions

It pains me to break my streak of "nos", but this is simply a matter of housekeeping that clears up the Colorado Constitution. Yes #1.

Referendum H - Elimination of State Business Tax Deduction

This sounds like a nice idea, penalize businesses for hiring illegal aliens. However, it's an enforcement nightmare. The overall amount of tax gain is capped at \$150K and my fear is it will end up costing more than that to put this in effect. Just say No #10.

Referendum I - Domestic Partnerships

I suppose that, over the years, I've become more of a social liberal while staying somewhat conservative on other items. On the societal side, I recognize that same sex couples do exist and I don't have a problem with those couples being given some rights to be recognized as such. I'm opposed to a redefinition of marriage, which is not being done by this referendum. So my initial conclusion would be in favor of this law. On the practical side however, there are a host of potential legal issues created by passing this. We the people don't have a true handle on how well thought out this proposed change is. My fear is that passing this will create a tangled web of complex legal actions. By the time the dust settles who knows what will be the result?

Being "twixt and tween" on this one, I give it a toss-up.

Referendum J - School District Spending

This one has a foot up on amendment 39 as it's not modifying the constitution. It's also better as it includes more realistic expenses in what it considers to be classroom spending. According to the blue book, only three districts do not comply with this 65% spending rule. It's probably only an adjustment in

accounting for those districts to comply with Ref J.

The numbers game says that Colorado ranks in the mid 40's in the US as far as classroom spending is concerned. Of course, we start off being 30th in per capita spending on education. I would wholeheartedly buy into this idea if we increase the per capita spending. But until we adopt the "spend money to make money" policy, that isn't going to happen. Just say No #11.

Referendum K - Immigration Lawsuit against the Fed

Gimme a break. Those in favor state "The federal government would become aware that Colorado wants federal immigration laws enforced." Hey, write the President a letter. We spent money to put this on a ballot? An even dozen on the Just say No's.

Amway, Walmart heirs dabbling in Colo. election

HseMajority 10/20 – Wealthy, out-of-state Republicans are playing the dirty politics game in Colorado, claims Joshua Rosenblum, executive director of the House Majority Project, the campaign committee for Democrats running for election to the Colorado House of Representatives. He points to three negative mail ads sent to Mesa County constituents earlier this week, distorting State Rep. Bernie Buescher's legislative record. The ads are paid for by a Republican attack group called "All Children Matter" (ACM), based in Alexandria, Virginia.

ACM is a national pro-voucher organization mainly funded by two rich Republicans: Betsy DeVos, whose family started Amway, and the Walton family, Wal-Mart founders. Oddly, says Rosenblum, the mailings have attacked Democrats on just about everything but vouchers including car insurance rates and taxes.

"I smell a special interest rat," said Demo-

cratic State Rep. Terrance Carroll, who sponsored and passed the charter school institute legislation during the 2005 session. "I don't think Coloradans want a national group with an anti-public education agenda telling them which candidate best represents their interests..."

Rosenblum says ACM is so desperate to defund public education they will stop at nothing to win a few state House seats. It's the only way they can advance their right-wing agenda especially after Colorado voters soundly rejected two school voucher measures on the ballot during the 1990s.

In 1992, 66 percent of Colorado voters killed the Universal Voucher Amendment. But special interest groups tried again in 1998, and were rejected by 60 percent of voters. The pro-voucher special interests came back in 2003 with legislation they passed under Gov. Bill Owens. Titled HB 03-1160, it is estimated it

would have sent more than \$230 million in tax revenues to private schools with little accountability. Later that year, a Colorado dis-

trict court ruled the new law was unconstitutional. In 2004 the Colorado State Supreme Court upheld the ruling.

Three judicial officers selected for excellence awards—

Colo. Judicial Institute to recognize Maes, others at annual fete

ColoJudBr 10/17 – District Court Judge C. Dennis Maes, County Court Judge Lynn J. Karowsky and Magistrate Louis A. Gresh have been selected to receive the 2006 Judicial Excellence Award from the Colorado Judicial Institute. The presentations will take place during the institute's annual Judicial Excellence for Colorado Dinner on November 16 in Denver.

"Hard work, dedication and creativity characterize these three able and experienced public servants," observed Chief Justice Mary Mullarkey, noting that they have touched the lives of thousands of people.

The three judicial officers work in the state court system. **Judge Maes** presides in the Tenth Judicial District (Pueblo County), County Court **Judge Karowsky** sits on the bench in the Nineteenth Judicial District (Weld County), and **Magistrate Gresh** is in the Eighteenth Judicial District (Arapahoe, Douglas, Elbert and Lincoln counties).

One district court judge, one county court judge and one magistrate who exemplify the highest standards of excellence are selected annually to receive the awards. Recipients were chosen for their management skills; control, innovation and creativity in the courtroom; extraordinary courage, energy

and tenacity, and of respect and confidence expressed by other judges, court staff, lawyers and others.

Maes seen as innovator for families, juveniles

Judge Maes was appointed to the district court bench in 1988. In 1995, he was named chief judge. Maes has spearheaded many innovative changes in the district. These have included creating a family court facilitator/case manager position to more effectively maneuver juvenile delinquency, dependency and neglect, and domestic relations cases through the judicial system.

Some of Maes' most beloved accomplishments focus on juveniles in the community. Along with a juvenile magistrate, the schools and Department of Human Services, he was instrumental in creating a truancy prevention program for at-risk youth. As part of this program, he supervises Friday afternoon study hall and works with parents to emphasize the importance of education. Maes also is proud of his work toward the General Assembly's passage of a bill that raised the mandatory school attendance age to 17.

Karowsky cited as teacher, mentor

Judge Karowsky was appointed to the Weld County bench 25 years ago. He first served as a magistrate for 15 years then was

appointed as a county court judge. For the last eight years he has served as the presiding judge of the county court. His career is marked by many accomplishments in the courts and community. In the courts, these include serving as a mentor to other judicial officers, participating in establishing the county's domestic violence court, and drafting small claims rules.

In the community, Karowsky was involved in establishing the first rape crisis hotline in Weld County and the battered women's shelter. Karowsky taught business law at the University of Northern Colorado and chaired the Monfort Executive Professor Program. He was named Professor of the Year in the UNC College of Business and its Department of Finance three times. He also has served as the president of the Weld County United Way and Weld County Bar Association, vice-president of the Weld County National Organization for Women, and board member of the Greeley Chamber Orchestra, the Greeley Philharmonic, the Union Colony Civic Center and Beth Israel Synagogue.

Gresh presides widely

Since joining the Douglas County bench in 1986, Magistrate Gresh has utilized his extensive family law expertise to efficiently and expeditiously manage his domestic dock-

ets. He also serves as a municipal judge in Castle Rock, Larkspur and Lone Tree, and previously served as a municipal judge in Parker and Foxfield.

Gresh has served on the Douglas County Partners Advisory Board, providing mentors to at-risk youth and serves on the Douglas County Youth Initiative working with at-risk youth. He also has served on the boards of the Rocky Mountain Heart Fund for Children, successfully working to require insurance companies to cover heart birth defects at the time of birth; Denver Mobility Inc., which helps ensure safe, reliable transportation for handicapped persons; and Douglas County Partners Advisory Board.

Health begins monitoring Wildhorse Creek for e. Coli

CityCoHealth 10/20 – Based on reports of children playing in Wildhorse Creek, the Pueblo City-County Health Department has begun monitoring E. coli levels on the waterway. The Colorado Department of Public Health and Environ-

ment reports Wildhorse Creek as exceeding recreational contact standards due to high levels of bacteria in the creek.

"Our results of tests conducted on water samples from Wildhorse Creek indicate that the levels of E. coli in the creek occasionally fluctuates above the water quality standard issued by the Colorado Department of Public Health and Environment," stated Dr. Chris Nevin-Woods executive director of the Pueblo City-County Health Department. She added, "It is thought that the source of these high bacteria levels is linked to surface water runoff, as has been shown in many creeks across the country. This runoff often includes animal waste and other pollution, and may release bacteria from creek-bed sediments following rainstorm events." Nevin-Woods described that only DNA testing can determine the source of the bacteria, and the Pueblo City-County Health Department is unable to perform this testing.

The Pueblo City-County Health Department recommends practicing good hygiene around any untreated surface water, such as Wildhorse Creek. Surface water sources are not regulated, like a swimming pool is regulated.

In addition to the risks associated with exposure to bacteria, Wildhorse Creek is also subjected to flash floods during storm events. This was evident during the large storms in the Pueblo area in September (Figure 1). Rushing floodwaters can sweep a person off their feet and pull them under, and possibly drown them. Children are particularly at risk from swift water flows following storm events. Flash floods can occur even if it is sunny outside due to rain falling on upstream areas in the watershed. This situation can cause the creek to change from a quiet trickle to a raging river without warning. For this reason, it is important that parents do not allow their children to play in Wildhorse Creek.

The Pueblo City-County Health Department will continue weekly monitoring of the situation of Wildhorse Creek. The Health Department is conducting public meetings and flyer distribution to alert residents near Wildhorse Creek of the risks associated with playing in creeks. •

Tracing women's right to self defense
