Pueblo City Schools Strategic Plan ...

As most of you know, I had the opportunity to serve on the PCS Strategic plan core team over the past few months. The plan was adopted by the School Board this month and the implementation process within the district has begun. Many of the comments from the public and as a result much of the discussion from Dr. Covington, have centered on the expansion of the number of school days to 215. While this may be the change with the highest visibility, it is only one part of a very comprehensive set of changes. To be honest, I was part of the Core Team that objected to this, and as a result, the actual number of days was lowered as a compromise. I'll spend some time in this column discussing my feelings on this aspect of the plan, but I still want to emphasize that this is only one part of the plan. The expanded number of days is based, for the most part, on the Japanese school system. Whether or not Japan has the top system would be a matter of some discussion but it is certainly one of the best school systems in the World. That said, there are school systems that have more days of classes than us that rank lower than us, and there are ones with less or equal days that rank higher. My arguments against the increase were, in addition to the statistics above, that a) this is not Japan — The U.S. has a different mindset, and b) we're looking at a single factor somewhat out of context from the entire picture. I doubt the first point requires any clarification. With regard to the second point, there are many other differences between the U.S. and Japan when it comes to education. Singling out the number of school

days MAY be a distortion of the statistics. I have to say 'may' since it is virtually impossible to correlate one factor of success. That said, there's little question in my mind that increasing the number of school days will create a better education. The compromise number allows for about four weeks of summer vacation and five weeks of time off through the rest of the year. This should allow students to retain more of what they learned the year before and eliminate the need for weeks of review at the start of the school year. What about the teen suicide rate in Japan? Oh, pooh. Again, there are a host of factors that contribute to that. I'm pleased that the strategic plan will greatly improve education in Pueblo. Let's move on past this one superficial aspect of the plan and look towards the overall gains the plan offers. Besides, this one aspect requires the most funding, both in capital expense for things like air conditioning, and for staff expense.

In brief..

Once again I had the opportunity to see the annual district school musical this past week and once I again I was amazed at the ability our high school kids have in putting on this production. This was a tough production that was carried out excellently. Hats off to all involved.

It may seem to you that I'm taking some extra time off this summer and I guess, from the standpoint of writing this column, this is true. There's no lack of topics to write about and I'll get caught up on them as summer winds down.

Getting it right, eventually...

It has been suggested that the term "War on Terror" has about the same propaganda value as the well-worn War on Drugs and War on Poverty. These tags ring out in a political speech, but their logic flies in the face of the historic reality that it's darned hard to find a civilization that wasn't plagued at some time by drugs, poverty, and terror, as well as a good many other versions of addiction, deprivation, disease, war, and/or injustice.



The Bush Gang coined the War on Terror phrase as a shorthand for all its efforts to keep U.S. citizens and their assets safe from the likes of Al Qaeda. If he were around today, I wonder if FDR would say, "The only thing we must resist is allowing ourselves to be terrified."

The Bush Gang was more interested in being perceived as our strong defender than in encouraging us to defend ourselves. This, they seemed to believe, would allow them to con-

solidate the power of their Conservative Oligarchy for decades to come, whereas arousing the general public would lead to a nationwide mobilization based on a broad, consensus view rather than their narrow Neo-Conservative dogma.

So George told us to go on with our lives as usual, and he and his people would protect us. Deflecting attention from his responsibility to protect the Constitution, he kept repeating, "My job is to protect the American people." When we failed to properly genuflect, he went to some pains to remind us over and over that he was a wartime president, which it turned out was code for Commander in Chief & the Decider ... which, to his gang, meant something like Supreme Dictator.

After over five years of Bush blunders leading to last year's election upheaval, we're still burned up. But now, folks are disgusted with both the Bush Gang and the new Congress.

The press and the pollsters are convinced that last year's election was about Iraq. To a point, this is true, but I'm beginning to think those who

voted against Republican control of Congress were not necessarily saying, "Pull out of Iraq." If this were the case, the efforts of the Democratic majority to force the President to reduce our presence in Iraq should have enhanced their popularity. It hasn't.

Last November, maybe the voters were saying to the Congress, "Stop protecting the Bush Gangsters. Their arrogant screw-ups are the reason we jumped blindly into (and have been losing in) Iraq from the very beginning."

Americans tend to think we are a can-do kind of people. Being embarrassed by a bunch of power-grabbing demagogues is hard to take, but allowing those nincompoops to harm our own troops while creating chaos, is excruciating.

We aren't as moralizing and superstitious as some would make us out to be. Most Americans hate to lose, even if it's a misguided fight they get suckered into, such as the Iraq mess.

We must not let the Bushies blackmail us by holding our troops in Iraq hostage. We have options.

• Under Bush's command, we have done about as much damage as good in Iraq, but at least

Sadam and his sons are long gone. We have learned that the democracy Bush tried to establish there is not suited to the Iraqi people. At any rate, it cannot be forced down their throats, so we should back off.

• Instead, we should narrow our strategy to fit the forces we can sustain indefinitely. Perhaps just target Al Qaeda and other outside psycho-gangsters from Iran, Syria, Saudi Arabia, and other nearby countries.

By April, we will have to let the Iraqis decide their own destiny, anyway, because Bush and the Congress have refused to enlarge our military through some form of national service. Six months from now, both our ground forces and their equipment will be severely stressed, another 500 U.S. troops will have been killed, and another 5,000 will be permanently maimed.

• Our NATO allies in Afghanistan – especially Britain and Canada – are having second thoughts because the Italians and Germans won't fight. The French aren't even involved there, but they did put troops into Lebanon for the U.N.

A reduction of our forces in Iraq would permit us to refocus on Afghanistan, with spe-

cial emphasis on the mountains bordering northwestern Pakistan, where Al Qaeda has been rebuilding its base of power among the autonomous tribes for about a year. One hears that we have from 12,000 to 17,000 troops in Afghanistan, which is more than all the other NATO forces combined.

• And most of our military tactics, in Iraq or Afghanistan or Timbuktoo, should be of a guerrilla or small-unit nature, at least for now, because the Iraq fiasco has proved that our professional military just isn't big enough to deliver sustained, overwhelming force.

The ideal rate of deployment of small units would be as fast as they can learn the local language and customs, plus how to make themselves useful wherever they deploy. If Bush is right, this particular struggle against nihilism, superstition and cruelty could last 50 years. If not, it is still certain that we must patiently get acquainted with the cultures from which Al Qaeda sprang. This will benefit homeland security, too.

A lighter footprint in Iraq will give our forces the flexibility and depth they need to get ahead of the psycho-gangsters and stay ahead. *jfh*

out and wet carpeting and furnishings need to be removed as soon as possible.

Residents should take proper steps to protect themselves during cleanup procedures.

- Individuals should wear gloves, enclosed shoes, long pants, and shirts with long sleeves while working to minimize skin contact with water and mud.

- Individuals who come into contact with the water or mud should wash their hands frequently with soap and clean, warm water. If clothing or shoes get wet, they should be removed and washed in warm water.

If an individual has open wounds and is exposed to water that may be contaminated, they should contact a physician or local health department for guidance regarding receiving tetanus and/or other immunizations.

If individuals experienced a power outage the following are guidelines regarding food safety:

If power is out for less than two hours, then food in your refrigerator and freezer will be safe to consume. While the power is out, keep the refrigerator and freezer doors closed as much as possible.
