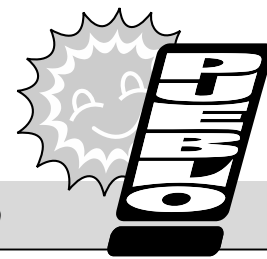

Election 2007

It perhaps presents more of a challenge to the electorate as well since we may need to learn more about the candidates before we mail in our ballots. It will be interesting to see the results.

We'll be voting on City Council members and School Board members, as well as a ballot issue regarding expansion of the convention center. In the past, I've mostly shied away from commenting on individual races, but this year I will break from that and present my opinions on each race.

The problem, as always, is that I truly believe we are

blessed with many good candidates for our local elected offices and that each believes they will make a difference and better the community. So, while I may have a favorite 'horse', it is usually not based on a negative opinion of the other candidates.

George laid out several examples of near-success in Iraq, including "reduced sectarian violence in Baghdad." It turns out that this reduction in daily civilian body count has been partially achieved by *not counting* some of the bodies.

Although I have lost the account of the exact indicator, apparently, when the bodies left in the streets are counted each morning, our forces now only count those with this indicator (such as, for instance, a bullet hole in the back of the skull). If bodies have been "drilled" to death or just had their eyes gouged out and their throat slit, but lack the bullet hole in their skull, they are not counted.

Thus the early-2007 count of 1,600 sectarian killings a month in Baghdad has been adjusted to appear closer currently to 1,000 a month.

In addition, most Baghdad Sunnis who could not afford to flee to neighboring countries have by now avoided torture and execution by allowing themselves to be herded and corralled in ghettos by their Sheeite militia tormentors. And up to 3 million middle class Iraqis, mostly from Baghdad, have fled to Syria and Jordan, so they are not available to be executed by sectarian Baghdad militias.

The Great and The Terrible...

During his talk, Clueless invoked the name of Petraeus the Great no less than eight times. If VP Cheney is George's brain, this general with a Yale PhD is the President's new heart, his inspiration. With Cheney the Terrible behind him and Petraeus the Great forging the way ahead of him, Clueless George believes he is truly

unstoppable. He may be right.

Succeed or don't come home...

With his dreams of glory aglow, Clueless confidently laid down his marker Thursday night, saying our new guideline in Iraq will be "return on success." He explained to us that this means troops will be brought home as they succeed in Iraq. This is not a red flag to ordinary civilian Americans, but it is a **stark threat to our military**. To a trooper, "return on success" means "*You can't come home unless you win.*"

Clueless George seems prepared to gamble our military, one trooper at a time, to prove that he is not a failure. He has a historic vision of himself so fantastic that it will outshine Spartacus, the rise of the Roman Empire, and more recently, the taking of Iwo Jima and Okinawa plus McArthur's masterful surprise Inchon Invasion of Korea. Clueless imagines his glory, and now that he and Cheney have nothing to lose and Petraeus as their scapegoat, reality is unthinkable.

We mentioned two weeks ago that Georgie should be impeached or otherwise curbed by those who "love" him. It is obvious that while those who love him continue to defend his grand design, he cannot be stopped by those who do not.

Those who love him blindly are prone to share his dream and his superstition: they believe in a glorious, story book victory of virtue over evil, buoyed miraculously by God himself. To them, George is a beneficent Caesar.

We are reminded that it was his friends who were forced to help end Caesar's appetite for glory, although the Roman Senate was never again more than a shadow of power. Our Congress must regain its Constitutional place as a bulwark against the American Imperial design of George's brain and

heart. Only his friends in Congress can stop George. He has already loaded the Supreme Court with doormat Imperialists.

But if through some quirk his fortunes improve significantly in the next six months, we could be pleased by this surrender to white supremacists, cartels and the corporate war machine.

For this reason, we hope his GOP allies in the Congress will engineer the dismantling of this Imperial Presidency and work with Democrat colleagues to build a strong Iraq strategy which fits a revitalized, bipartisan foreign policy. *jf*
