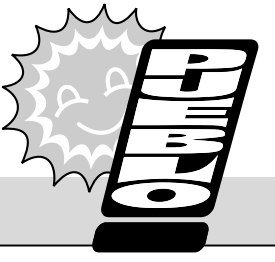

Election 2007

This odd-year election is particularly odd since there really isn't an 'Election Day'. This year's ballot will be a mail only ballot although there is technically an Election Day of November 6th. The ballots will be mailed this week and must be received by the County Clerk by 'Election Day'.

There are a few local issues and races that are worthy of note, at least in my mind. Here's a quick rundown on them:

•**City Ballot Issue 2a** – This one allows City Council to remove or appoint the City Attorney. Honestly, I have no idea of the pros and cons on this issue. So flip a coin or, even better, find out more information.

•**City Ballot Issue 2b** – This would allow raising municipal fines to a maximum of \$1,000. This is the second time this issue has come around and last time I flip-flopped on it after reading an opinion by Ray Aguilera; ending up against the proposal. This time, I'll start out against the proposal. Not because I'm opposed to raising the maximum fines, but because there is no differentiation in the proposed change as to how the fines would be raised. Would some poor senior citizen be subject to a thousand-dollar fine for weeds, the same as a graffiti artist who tags the Home of Heroes sign? While I'd imagine not, I imagine the writers of

these things can do a better job writing them before presenting them to the people. So 2b should be not to be.

•**City Ballot Issue 2c & d** – These two issues would take the City sales tax fee now being paid to vendors and put that money towards expansion of the convention center. Since I've routinely written in the past that money used for education and infrastructure is tax money well spent, I'd be a hypocrit if I didn't support this issue. Expanding the convention center will allow for larger groups to come to Pueblo and it ties in nicely with the expansion of the Riverwalk. There's been an explosion of hotel rooms built in Pueblo in the past few years so providing a larger facility for conventions and the like makes a great deal of sense. The money comes from vendor fees without directly increasing any taxes. We need to give the HARP area the best shot possible in its quest to become a destination so my vote is a yes on 2c&d.

City Council Elections...

Incumbents Ray Aguilera and Vera Ortegon are running for reelection; Larry Atencio is running unopposed in his district. Vera Ortegon is a community minded individual who has spent a lot of time working on community boards and organizations. She was appointed to council last year. I say let's give

her a chance to see what she can do with a full term.

Ray Aguilera on the other hand, is running for his second term on council. Just this past month, Ray was named as the US Hispanic Chamber of Commerce Government Advocate of the year for this region. This is no small feat for a City Councilman from a small city and it is an award he truly deserved. To a great extent, Ray represents the little guy in Pueblo. I've served with him on several groups over the past years and he provided a lot of thought provoking input, whether I agreed with him or not. He's a hard-working guy who loves the City and its people, so there's no question in my mind that he should be returned to Council one more time.

I don't have anything negative to say about the other candidates for, as usual, Pueblo is fortunate to have good people running for office. It makes little difference whether they are Republicans or Democrats; I think they have the best interests of our city at heart. Just remember to do your part and get your ballot in on time!

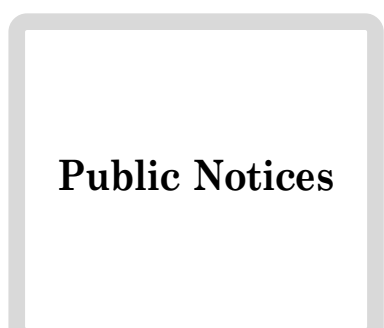
