Election 2007- Pueblo City School Board

With the odd-year mail-in ballot, I'm sitting here wondering how many people have already sent in their ballots. I know I received mine last week and it's actually ready to be mailed. I just have some silly feeling that I should wait till closer to Election Day to mail it.

This year, there are three seats up for grabs on the District 60 School Board. The three incumbents are running for re-election along with two challengers. Notably to me, and some that know me, I'm not one of the challengers this year. As some of you may remember, I was one of the finalists for the appointed Board position, which went to Phyllis Sanchez. After that, I said that I would run for the Board in 2007 if I would not be running against Phyllis, Shawn Yoxey, and Dan Comden. Since the three incumbents are running for re-election, I chose not to run as I had said I wouldn't.

It goes beyond that though. If I truly thought the existing Board was deficient I would have thrown my hat into the ring. However, I don't see any evidence that this is the case and running for the sake of running isn't something I want to do.

The existing Board has hired a new superintendent and adopted the new strategic plan. As a member of the strategic planning team, I saw first-hand the involvement and interest the Board

members had in developing the plan. I believe they support the plan and will do whatever they can do to put it into operation. Every action the Board takes is now linked to a specific goal in the plan. To me this is critical as members of the community put literally thousands of hours into development of the strategic plan.

So, the simple choice for me here is to return Shawn Yoxey, Dan Comden, and Phyllis Sanchez for one more term to help complete what they started.
