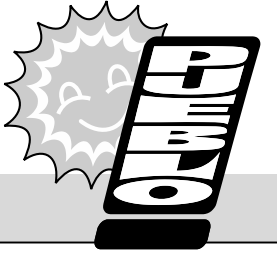

Highest foreclosure rates found in Adams County, Weld County

DeptLocalAff 4/15 – New foreclosure filings in Colorado were 23 percent higher during the first quarter of 2008 than during the same period last year. According to a report released today by the Colorado Division of Housing, there were 11,630 new foreclosure filings during the first quarter, compared to 9,443 for the same period last year. There were 39,915 new foreclosure filings reported during 2007.

Foreclosure filings increased 6 percent since the fourth quarter of 2007, climbing from 10,955 during the fourth quarter to 11,630 during the first quarter this year.

Statewide, there was one foreclosure filing for every 159 households, with the highest foreclosure rates found in the Denver metro area and in Weld County. Adams County had the highest foreclosure rate with one foreclosure filing for every 86 house-

holds, while Weld County showed one foreclosure filing for every 102 households.

The report also tracks foreclosure sales at auction which increased only 5 percent year-over-year during the first quarter. The small increase in sales, however, does not necessarily indicate any dramatic decline in the number of foreclosing properties proceeding to final sale.

A recent change to the foreclosure process took effect on January 1, creating a transition period during which the number of foreclosure sales dropped off dramatically. For example, during March, some counties that reported hundreds of foreclosure sales during January and February reported only a few dozen sales in March. Even fewer sales were reported during April. Due to the new foreclosure process, no foreclosure filed after January 1 could proceed to sale before April 30, creating a dip in sales during March and April.

Foreclosure sales occur when a foreclosing property is sold to the lender or a third party. During the first quarter, there were 5,875 foreclosure sales, compared to 5,586 for the same period last year. There were 25,320 foreclosure sales during 2007.

Among Front Range counties, Douglas County and El Paso County experienced the most growth in new foreclosure filings. Douglas County's filings were 78 percent higher during the first quarter of 2008 than during the same period last year. Foreclosure filings in El Paso County were 47 percent higher during this year's first quarter than last year's.

According to the study, foreclo-

sure filings for 2008 are likely to be 15 percent higher than 2007 totals. Foreclosure filings increased 30 percent during 2006, and 40 percent during 2007.

"We're glad to see a break in the rate of increase in new foreclosures opened," said Kathi Williams, Director of the Colorado Division of Housing and co-Chair of the Colorado Foreclosure Prevention Task Force. "What we'd really like to see is a drop in the total number of new foreclosures this year. However, adjustable rate mortgages will continue to reset through 2009, and the cost of living looks like it will continue to increase this year. That will likely mean we won't see any drop in foreclosure numbers this year."

According to the report, the new change in the process means it will be difficult to analyze data about foreclosure sales at auction until later in the year. The new change in the foreclosure process means that there will be more time between when the foreclosure is filed and when it proceeds to final sale. The process was changed by law during the 2006 and 2007 legislative sessions with the intent of allowing more time to avoid final foreclosure.

"We don't expect the new foreclosure process to impact foreclosure filings much, but we do hope to see a positive change with the numbers of properties proceeding to final sale," said Michael Rosser, co-Chair of the Colorado Foreclosure Prevention Task Force and a mortgage industry consultant. "With all our efforts with the Foreclosure Hotline and the loss mitigation offices of mortgage companies, we think more properties can be saved from that final sale."
