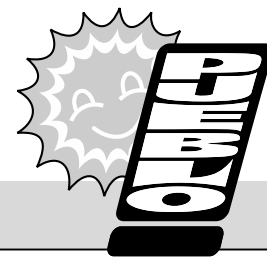

Gov. applauds \$22 million increase in PILT payments

GovOffc 11/20 — Gov. Bill Ritter on Thursday praised members of Colorado's congressional delegation for their role in bolstering Payment In Lieu of Taxes (PILT) payments to Colorado counties.

The Congressional "Financial Rescue" bill increases funding for both the Department of Interior's Payment in Lieu of Taxes (PILT) payments and Forest Service Secure Rural Schools and Community Self-Determination Act PILT payments, which will be distributed shortly. Together, these will provide \$22 million more in these annual payments to counties than was expected under the

traditional formulas.

The Colorado Department of Local Affairs (DOLA) works with counties to optimize the calculations for distributions under these programs.

Counties in Colorado face increasing difficulty with the costs of public facilities and services across the vast spaces they serve. This federal funding support reflects the fact that the federal government owns significant land (23 million acres) in these counties, which is exempt from taxation. These lands incur significant costs to the counties providing access, public safety and general government services.

PERSPECTIVE

Is deflation spelled d-e-p-r-e-s-s-i-o-n?

Now that the election is over, we can concentrate on real life for awhile. The winter holidays are just days away, although the weather seems to indicate it must be fall.

Gas prices are still plummeting, so some folks may drive to Gramma's for Thanksgiving or Christmas. Add some increase in air, bus, and train travel for the holidays and we may expect world oil prices to temporarily stop falling.

Besides, oil has already dropped from \$147 to around \$49 a barrel. This is supposedly due to an estimated drop in demand of just 5 percent, but the dollar is about 25 percent stronger, too. So, in July dollars, oil would be about \$65 a barrel. All this manipulation of numbers still doesn't account for gasoline dropping from \$4 a gallon to \$1.80, so we may conclude, as was suspected by many at the time, that the July price included a big speculation bubble.

Needless to say, the oil bubble burst as did the housing bubble



and the toxic stock bubble which pumped up the housing bubble. Now we are seeing signs that much more than housing construction has taken a hit. This week, the old Detroit Big Three auto companies—Ford, General Motors, and Chrysler — sent their top execs to Congress to borrow \$25 billion or so to tide them over as vehicle sales have dropped to less than half of normal expectations over the past few months.

The current lame duck session of Congress is loaded with just enough left-over free market purists to stop any such auto loan from getting through the Senate. These mostly-Conservative purists point out that the Big Three have done everything in their power since World War II to resist progress and innovation in the transportation industry. (They don't mention that it is they who consistently encouraged the Big Three in their recalcitrance.)

They say, also, that the obvious solution to Big Autos' failures is the same one taken by the airlines, that solution being bank-

ruptcy reorganization. We agree wholeheartedly with the purists' reasoning, from an academic perspective. However, the U.S. economy (and thus, probably, the world economy) is now teetering over the edge of deflation, which is a red flag for a precipitous slide into severe recession, if not actual depression.

It may seem great to go shopping for Christmas and find toys on sale way before the holiday at 60 percent off. Just as we mentioned earlier that the drop in the world oil price is partially an indicator of the dollar growing in value, so is the sale of desirable items such as Christmas presents at 40 percent of normal.

Our currency grows in value when sales begin to contract. Then production falls. As production is winding down, excess goods and services become available at deflated prices—to attract scarcer dollars. The scarcer dollars (real or imagined) thus become much more valuable, so the products offered for sale are less expensive. But, if potential buyers are (or feel) poorer because they are also the workers who ei-

ther lost jobs or expect to lose jobs as production falls, then they will continue to resist buying. Obviously, once this process begins, deflationary pressures steadily grind the economy down. And deflation was a hallmark of the infamous 1930s Depression.

The prospect of such a scenario becoming a full-fledged reality is quite enough to convince me that Congress should make some provision for the auto makers to carry them through the next three months until the new President and new Congress can deal with the problem more comprehensively after January 20.

However, bankruptcy reorganization next year should not be off the table for these sicko companies. The fact that the heads of the Big Three came to Washington majestically in three private jets, fully prepared to give Congress the spectacular opportunity to lend them money with no strings attached...this fact tells us why the Big Three and a lot of the rest of Big Business is unraveling: its management is fatuous, narcissistic, cowardly, unimaginative and incompetent. jfh
