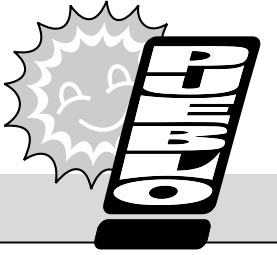

When the dreams of dreams begin to shatter...

A couple of weeks ago, we outlined some of our impressions of why there is a very vocal, almost ferocious minority of Americans who claim to oppose any change whatsoever in the way we get our healthcare. After watching the news accounts of these cantankerous folk throwing their tantrums at public gatherings this month, we suspect additional factors are spurring them on.

•The American Dream's failure: Most of us have sensed a very gradual, often barely perceptible, but very real psychic letdown over the decades since our triumphant emergence from World War II. By 1945 and from that time to now, the American experience has been defined domestically as the proof that U.S.-brand freedom, justice, resourcefulness, innovation, and economics are superior to all others. It has been difficult to find the slightest acknowledgment that accidents of geography, natural resources and climate may have been just as important.

Just as we have depleted our natural resources and the importance of geography has been transformed by technology, now also we are threatened by unknown difficulties from global climate change.

The letdown is extremely frustrating because most of us are ill-equipped to understand the scien-

tific and technological efforts being proposed and mounted to meet and cope with these perplexities.

Our ignorance is allowing fear to creep in...and that fear is what drives many of us to lash out against what may appear to be new-fangled or foreign notions.

•The Neocon Dream's failure: On top of the general collapse of the American Dream, nearly half of us bought into the Neo-Conservative Dream which was the product of a heady awakening of commerce during the Reagan years. The Reagan notion of trickle-down economics depended on freeing big business from such social obligations as health insurance, retirement funding, safe working conditions, and a sustainable, safe environment.

Reaganomics plans depended on de-horning organized labor, even though a lot of Reagan's support came from Middle Class voters whose well-being depended directly upon strong union representation. Many of the unions played into Reagan's hands. Some discredited themselves by being reactionary and thuggish, depending on their might to stop the overwhelming march of technology toward cheaper foreign labor.

But what really saved Reagan's presidency was the pure luck of OPEC falling apart in the mid-1980s. Oil fell to \$3 a barrel and
