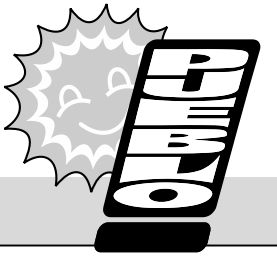

Lying for money...not health

Several front groups have been busy for a few months now, funneling resources and personnel to broadcast radical propaganda (misinformation) regarding health care reform. The bulk of the lies have been calculated to instill fear in the old, the infirm and the helpless among us.

The dirty job has been effective. There is nothing more pathetic than a full-grown, mature adult who has given up his or her reasoning faculties in the face of ugly, terrifying, baseless lies.

The corporate interests which initiate the lies are driven by greed; those thousands of individuals who are incited to spread the terror willy-nilly have been convinced that reform of the American health care mess will destroy our freedoms. At one of a Congress member's open meetings held recently, a well-meaning but inane attendee was recorded saying he didn't see the word "healthcare" anywhere in the Constitution. Many others have been heard screaming, "Don't let the government get hold of my Medicare!" —apparently ignorant of the fact that Medicare has always been a government program.

All this manic behavior is unworthy of a free people but perfectly predictable in a society where the secrecy of private greed (euphemistically called "the free market") is glorified, while open public institutions are reviled. The reason such mania occurs again and again in this nation may be that we are neither adequately educated to understand the issues nor availed of the salient facts necessary to judge those issues. Lacking

these vital ingredients, we are prisoners of our ignorance.

The human mind is most easily swayed by anecdotal evidence ... an account of an isolated incident which is somehow related to the issue under consideration. The isolated incident is represented by its teller as if commonplace. To be convincing, the anecdotal evidence is usually sketchy but graphic and facts are often suppressed, omitted or distorted to achieve the desired effect. Such accounts are often presented as testimonials. Almost all political advertising on TV, in mailings and phone campaigns is this type of bait-and-switch or "swiftboat" propaganda.

The most reasonable method of judging healthcare proposals would be to compare them to those various healthcare systems already in place for many years in dozens of other countries. Unfortunately, because of our national chauvinism, it is almost impossible for our political leaders to refer to foreign systems because, in the fantasy surrounding the true American "patriot," all other nations are purported to be inferior and therefore unworthy of comparison with our glorious democratic republic. Because of this national super-egoism, a politician who resorts to such comparisons is easily branded "un-American."

Is it any wonder some among us insist that we pay double, even triple, what other nations pay for healthcare? Is it any wonder we cling to a malaise of secretive health industry monopolies which ration their services and products arbitrarily (and piecemeal) to the highest bidders?

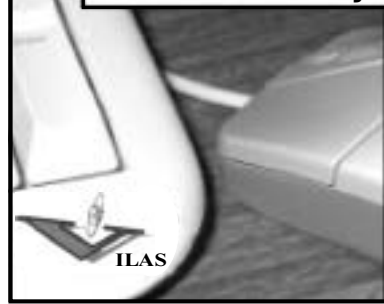
