Building for the future while spoiled brats grumble...

This week, Speaker Pelosi came out with a revision of the House comprehensive healthcare reform bill. The House Republican leadership immediately panned the proposal and all their dupes stonewalled it. Of course, with the exception of Sen. Olympia Snow of Maine, conservatives in both the House and Senate have opposed all the Democrats' health proposals since the session began in January. But on Tuesday, they offered their own proposal—a warmed-over version of several failed Republican offerings from the past which do little more than guarantee the right to pay exorbitant “blackmail” for care and medication.

There's a group calling itself part of the Tea Party up in the Weld County area that's against all the Democrat plans offered so far. This bunch of folks is afraid of reform. They have become accustomed to paying the corporate system 8 to 12 percent more every year for private healthcare and private health insurance. They don't seem to think the average citizen deserves good, affordable healthcare. They just can't imagine any plan could succeed if it doesn't cheat the sick and make corporations filthy rich.

They refuse to look at the plans that have been in place for decades in various countries around the world because they have been brainwashed to believe that all these other countries are inferior. They don't believe there is any other way to handle healthcare because they can't get their heads out of the jingoistic bottle they've lived in most of their lives. They would rather die stupid than learn from or experiment with the possibility of improvement.

Anti-health groups such as the one in northern Colorado are backed by ultra-conservative Republicrats who are after Cong. Betsy Markey's House seat next November. These people would say or do almost anything (for instance, they would gladly deprive their constituents of decent, affordable healthcare), just

to replace Markey with a pawn from the Storm Trooper wing of the Republican Party.

This kind of thuggery reveals how cruel and predatory the American political system has become since five of our Supreme Court justices decided that a dollar is a vote. The Gang of Four—Justices Thomas, Roberts, Scalia, and Alito—have, with the occasional assistance of Kennedy, bent open government into a pretzel of subservience to elitist corporate manipulators.

It is pretty clear that Pres. Rocky is in a steely tussle with the international bankers we bailed out last year. He won't have enough clout to kick their lackies out of his Cabinet unless and until the Democrats make gains in Congress in next November's election. Meanwhile, many moderates and independents are wondering why he hasn't already parted the Red Sea and a few other miracles.

These impatient millions who voted for Rocky but are wavering now are political neophytes; they can't understand how difficult it is to pass legislation in a Senate where a solid 60 votes is necessary to keep the obstructionist reactionaries of both parties from gumming up the works with a filibuster.

Furthermore, the \$700 billion invested in failing banks early in the year so effectively stopped the world economy's collapse that folks have already forgotten (if they ever knew) just how bad the situation was. The bankers want us to forget.

We are protected in many ways from the kind of devastation that our grandparents and their parents faced 80 years ago in the Great Depression. At that time, there was no Social Security, no unemployment insurance, no workman's comp, no Medicare, and no FDIC insurance.

As a friend commented to me recently, there is no comparison between the Great Depression and this Great Recession. “At that time,” she said, “even basic needs were hard to come by; today, most Americans aren't desperate enough to understand the difference between wants and needs.” jfh
