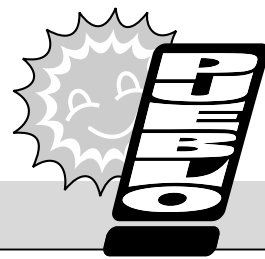

Commission to select County Court nominees

JUDGE KATHLEEN K. HEARN RETIRING FROM PUEBLO COUNTY BENCH

ColJudclBr 4/3—According to Gerald Marroney, Colorado Court Administrator, the Tenth Judicial District Nominating Commission will meet Tuesday, June 14, at the Pueblo Combined Courthouse to interview and select nominees for appointment by the governor to the office of county judge for Pueblo County.

The vacancy will be created by the retirement of the Honorable Kathleen K. Hearn. The vacancy will occur on July 1.

To be eligible for appointment to fill the vacancy, the applicant must be a qualified elector of Pueblo County and must be admitted to the practice of law in Colorado. The current annual salary for this position is \$123,067. The initial term of office of a county judge is a provisional term of two years; thereafter, the incumbent county judge, if approved by the voters, has a term of four years.

Application forms are available from the office of the ex officio chair of the nominating

commission, Justice Allison H. Eid, 101 W. Colfax Ave., Suite 800, Denver, CO 80202; and the office of the district administrator, Bobbi Griffin, 320 W. 10th St., Pueblo, CO 81003. Applications also are available on the Judicial Branch's web page at <http://www.courts.state.co.us/Careers/Judge.cfm>.

The original and seven copies of the application must be filed with the ex officio chair no later than 4 p.m. Tuesday, May 24, 2011. Late applications will not be considered. Any person wishing to suggest a candidate to fill the vacancy may do so by letter to be submitted to any member of the nominating commission, with a copy to the ex officio chair, no later than 4 p.m. Tuesday, May 17.

The members of the nominating commission for the Tenth Judicial District are: Randall Jorgensen, David Abeyta, James Croshal, Patrick Garcia and Vera Ortegon, all of Pueblo; and Lois Michaud, Pueblo West. The commission has a vacancy for a non-attorney which may be filled before the June 14 meeting.
