Nine confirmed cases of EHV-1 in Colorado horses

ColoAgr 5/20—The Colorado Department of Agriculture continues to investigate the spread of Equine Herpesvirus (EHV-1) in the state. As of 1 p.m. Friday, nine cases of horses with equine herpesvirus myeloencephalopathy (EHV-1) had been confirmed.

In addition:

—Two horses, which tested positive for EHV-1, were euthanized after showing severe neurological signs associated with the disease.

—22 suspect cases. Suspect cases are those horses that are believed to have been exposed to EHV-1 but confirmatory tests are still pending.

—12 quarantine and hold orders have been issued in 8 counties (Bent, Boulder, Garfield, Gunnison, Larimer, Mesa, Morgan, & Weld).

Colorado State Fair Horse Shows Cancelled

Colorado State Fair organizers have voluntarily cancelled three equine events following the spread of EHV-1.

—Zamora Roping originally scheduled for May 20-22, 2011. Reschedule date pending.

—Mounted Shooting Regional originally scheduled May 27-30, 2011. Rescheduled for October 7-10, 2011

—Sagebrush Slide Cow Horse Show originally scheduled June 1-5, 2011. Rescheduled for August 10-14, 2011

“We decided to reschedule these events to limit the number of horses traveling to and from our fairgrounds,” said State Fair General Manager Chris Wiseman. “Our horse shows are concluded on page 12

Answers to Questions provided by *E-The Environmental Magazine*

Dear EarthTalk: I heard that timber thefts are increasing across the country. Why would people steal timber and is it a particular kind for a particular use? —*Rosie Ng, Stanwood, WA*

People are stealing timber for the same reasons they steal anything: to profit from someone else's hard work. What makes timber thefts that much harder to stop is the fact that, most of the time, they occur in remote forested areas and loggers typically don't have to document their sales as meticulously as other kinds of natural resource extraction. With the economy still in the doldrums, it's not surprising that timber thefts appear to be on the rise, at least based on anecdotal evidence from around the country.

"Timber theft can range from a landowner cutting down a neighbor's tree to loggers stealing hundreds or thousands of trees from private or public lands," reports Lori Compas in the September/October 2010 issue of *E Magazine*. "Investigators say it's difficult to calculate the exact number of trees lost to theft, but losses are estimated at \$3 million over the last five years in Mississippi alone."

She cites one example there whereby a logger was arrested on three counts of timber theft after clearing some \$375,000 worth of trees from land set aside to benefit local schools.

In some cases, thieves are targeting specific types of rare or expensive wood, such as the distinctively patterned birds-eye maple used in some high-end musical instruments. Since there is no way to tell if the wood inside a maple tree will show the birds-eye pattern without cutting into it, thieves aren't scared to damage or potentially kill a tree to find out. "We can see where they've notched trees [on state-owned forest land] to see if they have that desirable pattern," says Larry Raedel, chief law enforcement officer for the Washington State Department of Natural Resources. "When they find one that does, they cut down the entire tree and pack out a five- or six-foot section. They might make \$300-\$400 for a slab of birdseye."

Of course, on the other end of the spectrum, more complex schemes involve unreported or falsified mill receipts. "For instance, a logger might have a legitimate contract to cut timber on a parcel of land, with the understanding that he will cut certain trees, take them to a sawmill, receive payment and pay the landowner a portion of the receipts," reports Compas. "The trick is that he might take the logs to several different mills and only report the sales from one mill, pocketing the proceeds from the others."

In response to these more sophisticated tactics, law enforcement is starting to step up efforts to catch timber thieves red-handed by the use of track-

ing paint, surveillance and hidden cameras. Often, other loggers will even tip off local authorities about a rogue member of their industry perpetrating such crimes.

According to *Tree Farmer* magazine, legislatures and courts in various states are also starting to assign stiffer penalties for timber thefts. "Not only will actual or compensatory damages be awarded, but also, in the proper situations, swift and severe penalty awards and punitive damages will be handed down by the courts," *Tree Farmer* reports. Unlike in the past, timber thieves today often must answer to civil trespassing charges along with larceny of natural resources—and may be expected to pay back not only the value of the stolen timber but also the cost of reforesting the site(s) in question. Timber thieves who haul their take out of state might also face federal charges for transporting stolen timber across state lines.

Water Availability Task Force tackles south, southeastern drought conditions

WATF 5/17—Based on data provided by state and federal climate experts, the Colorado Water Availability Task force has invoked special drought and agricultural impact initiatives due to serious concerns about drought conditions on the Eastern Plains south of the I-70 corridor, in southeastern Colorado, and in the Rio Grande Basin.

The southeastern plains of Colorado continue to deal with deteriorating drought conditions, while the Rio Grande and the Southwestern corner of the state are also experiencing below average precipitation.

The National Weather Service has issued drought statements for much of eastern Colorado, and the US drought monitor has introduced D3 - extreme drought conditions in all of Baca county and portions of Las Animas, Bent and Prowers counties.

In the mountains, La Niña conditions continue to influence weather with above average moisture; new snow water equivalent records have been reported at 46 measuring sites within the central and northern mountains. Statewide, reservoir storage is near average, with many operators across northern and central Colorado preparing for reservoirs to spill during the runoff season.

The eastern plains of Colorado have received well below normal precipitation since the beginning of the water year in October 2010. In many southeastern communities, conditions continue to deteriorate.

The USDA has designated the Colorado counties of Baca, Cheyenne, Kiowa, Kit Carson, & Prowers as contiguous counties to Kansas counties that were declared primary natural disaster areas, due to losses caused by drought. This design-

ation qualifies these counties for natural disaster assistance.

The Colorado counties of Baca, Bent, Las Animas, & Prowers also met the trigger (D3 on the US Drought Monitor) for the USDA Livestock Forage Disaster Program, which provides cash payments to eligible producers who suffered grazing losses for eligible livestock because of drought on federally-managed grazing land.

According to the U.S. Drought Monitor, 60% of the State is now experiencing D0, D1, D2 or D3 status, which respectively represents abnormally dry, moderate, severe and extreme drought conditions.

The drought conditions that have covered the eastern plains of the state throughout the fall/winter have continued to deteriorate with D1 and D2 covering much of Colorado east of the divide. D3 conditions have been introduced in far southeast corner of the State near

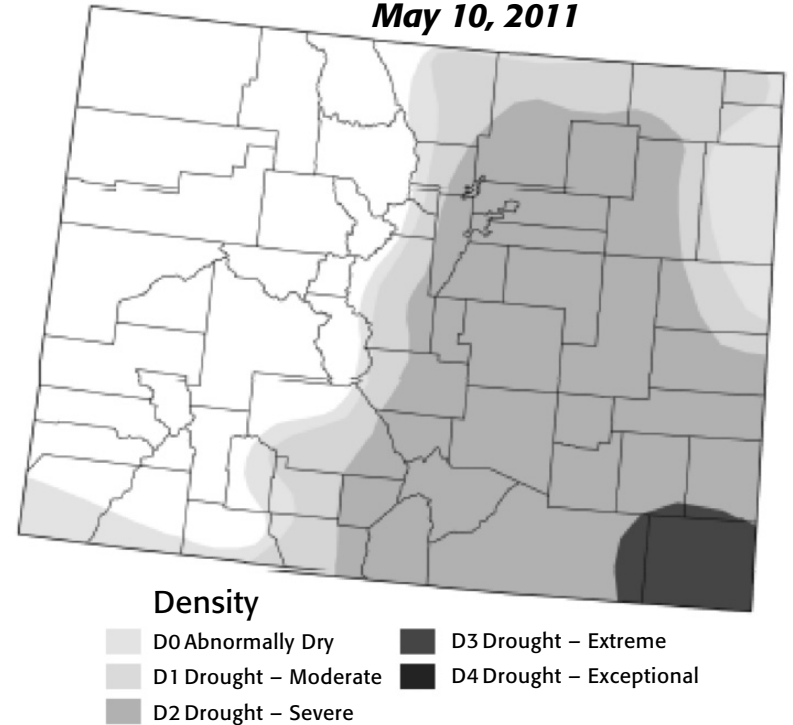
Baca County.

Despite relatively normal precipitation levels in April, the basins in the south and west part of the state: the San Miguel, Dolores, Animas, and San Juan as well as the Rio Grande remain just below average for the water year to date (Oct 2010 to the present).

Recent precipitation along the Front Range has helped to alleviate, but not eliminate, dryer than normal conditions.

Statewide, snowpack is 147%, with six of eight basins above 100% of average. The Yampa/ White has the highest percent snowpack at 179% of average; the Colorado, Gunnison, Arkansas, North Platte and South Platte sit at 165%, 145%, 116%, 172%, and 153% of average, respectively. The basins in the southwest corner of the state: the San Miguel, Dolores, Animas, and San Juan, are near normal at 94% of average. The Rio Grande remains below normal at 85%.

important to the Fair and to Colorado as a whole and we want to be proactive in protecting our horse community."

Facts about EHV-1 Vaccines

The common vaccines available for EHV-1 immunization do not protect against the neurological form of EHV-1 disease which is commonly called equine herpesvirus myeloencephalopathy (EHM). These immunizations do protect against the respiratory and abortion forms of the disease.

EHV-1 vaccines are thought to reduce the shedding of the virus and may decrease the amount of circulating virus in the system of infected horses. So vaccinations prior to infection may help reduce the severity of an outbreak.

In the face of an EHV-1 outbreak, the value of vaccinating EHV-1 affected horses or exposed horses is questionable and may be detrimental to the horse. When an EHV-1 outbreak occurs, it may be helpful to give

an EHV-1 booster immunization in a previously vaccinated, unexposed horse.

Owners are advised to consult their veterinarians to determine the best vaccination and treatment strategy for their horses in their particular situation.

New Travel Requirements for horses entering state

Standard requirements for horses entering Colorado include a health certificate issued within 30 days of their arrival and a negative Coggins test within 12 months. The new requirement consists of a permit to enter the state. Horse owners who wish to bring their horse into Colorado must first call their veterinarian. That veterinarian can then contact the Colorado Department of Agriculture's State Veterinarian's Office at (303) 239-4161 and request a permit number. That number would then be included on the health certificate.

Additional travel tips for

horse owners traveling to or from Colorado include:

1.) Contact the State Veterinarian's Office of the destination state to find out if travel requirements have changed for that state.

2.) Call organizers of the event to see if they have new health requirements or if it has been cancelled.

3.) If traveling, practice appropriate biosecurity measures. Biosecurity tips may be found at www.colorado.gov/ag.

4.) Isolate any new animals and those returning to the home premises for three weeks when possible.

5.) Use separate water, feed supplies and equipment.

6.) Continue to monitor the CDA webpage at www.colorado.gov/ag for further information to aid in the decision making for transporting horses.

General Disease

Information Detailed:

EHV-1 is not transmissible to people; it can be a serious equine disease that can cause

respiratory and neurological clinical signs; it can even result in death. The most common way for EHV-1 to spread is by direct horse-to-horse contact. It can also be spread by contaminated tack, equipment, and people's clothing. In addition, the virus can be spread through aerosols (airborne) for a limited distance.

Symptoms:

Symptoms include fever, decreased coordination, nasal discharge, urine dribbling, loss of tail tone, hind limb weakness, leaning against a wall or fence to maintain balance, lethargy, and the inability to rise. While there is no cure, the symptoms of the disease may be treatable. Horse owners should isolate any sick horses and immediately contact their veterinarian. Any individual horse with clinical signs consistent with neurological EHV-1 infection should be removed immediately from the area and placed in a separate enclosure for isolation.
