A Fragile Voting System

than two centuries of practice, we'd know all about running efficient and accurate elections. Voting, after all, is the great shared ritual of democracy.

Since 2011 began, 16 states have passed new laws that for the most part have made voting more difficult. The results will make it harder to vote this year for some 5 million Americans, according to the Brennan Center for Justice at NYU Law School.

need to make elections administration a top priority — updating systems and eliminating errors, doing more to register citizens, making voting convenient and promoting information on registration and the voting process.

Surely it's worth it. The legitimacy of our system of voting is strengthened by increased access for citizens and their confidence that votes are counted accurately and securely. Elections are contests over power. Ensuring that Americans have no reason to doubt the results is vital to our system's health.
