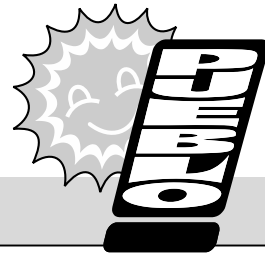

Colorado Health urges whooping cough shots

ColoHealth 8/20) - The head of the State Health Department issued a whooping cough (pertussis) immunization warning this week.

Dr. Chris Urbina, chief medical officer and executive director of the Colorado Department of Public Health and Environment, said Monday, "We are alerting the public to an epidemic number of pertussis cases in Colorado and are urging Coloradans to get vaccinated against pertussis."

From Jan. 1 through Aug. 11, 2012, a total of 715 cases of pertussis have been reported in Colorado, compared to a 2007-2011 average of 158 cases during the same calendar period.

Rates of pertussis are highest among infants under 6 months of age, followed by infants 6 to 11 months old, and children 11-14 years. Though the increase is widespread, the largest numbers of cases have been reported from Adams, Arapahoe, Boulder, Denver and Jefferson counties. There have been no reported deaths due to pertussis in 2012.

Urbina said, "Infants are particularly susceptible to severe disease due to pertussis and have much higher rates of hospitalizations and deaths due to pertussis. Infants are too young to have received all the doses necessary to protect against pertussis, so immunizing people who care for infants and who spend time around infants is key."

The department is advising that vaccination is the safest and most effective tool to prevent the spread of pertussis. Pertussis immunizations are recommended for all children and adults, but it

is particularly important for people who have contact with infants to be up to date on their immunizations.

Ideally, the vaccine should be received at least two weeks before beginning contact with an infant. Parents should ensure their children are up to date on their vaccines, including pertussis.

Additionally, the pertussis vaccine, Tdap, is recommended for the following groups:

- Pregnant women in the third or late second trimester
- Parents of infants under 12 months of age
- Caregivers of infants, including grandparents, babysitters and child care workers
- Health care workers
- Others who plan on having close contact with an infant
- All adults who need a tetanus booster, if they previously have not received Tdap

About the infection...

Pertussis is a bacterial infection of the respiratory tract that can easily spread though the air in droplets when an infected person coughs or sneezes. The illness often starts with cold-like symptoms, including sneezing, a runny nose and a mild cough. Often there is no fever or only a low-grade fever. The cough becomes more severe during the first week or two and often is characterized by episodes of rapid coughs (coughing fits), followed by a high-pitched whoop or a coughing fit followed by vomiting. The cough may last for a couple of months and is more frequent at night.

Since symptoms experienced by adolescents or adults may be relatively mild, individuals may not realize they have pertussis; yet they still can spread the disease to others, including newborns and children who are not fully immunized.

Young infants with pertussis often do not have a cough but experience apnea (periods of no

breathing) or gasping. The disease may be fatal in some cases, particularly in infants.

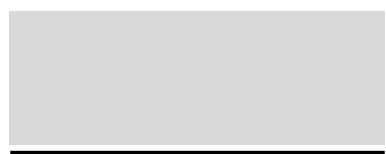

If you were served outside of the State of Colorado or you were served by publication, you must file your Response with the clerk of this Court within 35 days after this Summons is served on you to participate in this action.

Your response must be accompanied with the applicable filing fee. The Petition requests that the Court enter an Order addressing issues involving the children such as, child support, allocation of parental responsibilities, (decision-making and parenting time), attorney fees, and costs to the extent the Court has jurisdiction.

Notice: Colorado Revised Statutes §14-10-123, provides that upon the filing of a Petition for Allocation of Parental Responsibilities by the Petitioner and Co-Petitioner, or upon personal service of the Petition and Summons on the Respondent, or upon waiver and acceptance of service by the Respondent, an automatic temporary injunction shall be in effect against both parties until the Final Order is entered, or the Petition is dismissed, or until further Order of the Court. Either party may apply to the Court for further temporary orders, an expanded automatic temporary injunction, or modification or revocation under §14-10-125, C.R.S.

A request for genetic tests shall not prejudice the requesting party in matters concerning allocation of parental responsibilities pursuant to §14-10-124(1.5), C.R.S. If genetic tests are not obtained prior to a legal establishment of paternity and submitted into evidence prior to the entry of the final order, the genetic tests may not be allowed into evidence at a later date.

Automatic Temporary Injunction—By Order of Colorado law, you and the other parties:

- 1.) Are enjoined from molesting or disturbing the peace of the other party; and
2.) Are restrained from removing the minor child(ren) from the state without the consent of all parties or an Order of the Court modifying the injunction; and

2.) Are restrained, without at least 14 days advance notification and the written consent of all other parties or an Order of the Court, from cancelling, modifying, terminating, or allowing to lapse for nonpayment of premiums, any policy of health insurance or life insurance that provides coverage to the minor child(ren) as a beneficiary of a policy.

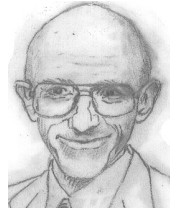

PERSPECTIVE by Tribune Editor Jon Heaton



As we mentioned last week, our infrastructure is collapsing because we have cut taxes too low at both the state and national levels. But far worse, we have deliberately put our hands squarely underneath our butts while we watch our cities, our states, our nation, our continent—even our planet—proceeding into an ever-accelerating meltdown.

Yes, we seem oblivious to the dire symptoms of global warming which are gathering momentum all around us. Instead, at least half of us are consumed with the imaginary threat of big government. Split another way, half of us are hell-bent to, once and for all, hand our individual freedoms over to a handful of international corporations which thrive by producing greenhouse gases, wasting valuable natural resources, and herding us like sheep through a perpetual shearing.

How could this happen? It may be that we are like a frog placed in a pan of cool water which is then ever-so-gradually heated up until the frog is cooked in place. The change in water temperature is so gradual the frog just doesn't notice until it's too late.

Like the frog, we operate on the assumption that our planet just recycles the same reliable changes through the seasons year after year with only minor anomalies. We just can't believe this good old planet is shifting environmental conditions so significantly that human civilization is inexorably undermined while we watch.

The Mississippi is the lowest records have ever shown, some 15 feet below previous lows. So low that salt water from the Gulf of Mexico is making its way 90 miles up the river and still coming. So low that barges can carry only about half what they "normally" carry in order to reduce their depth in the river so they can get over sandbars. So low that traffic could not get through at certain points this week.

The Arctic ice is melting so fast that it is now estimated it will be clear for ships to pass over North America in summer within about 10 years. Five years ago, measurements indicated this couldn't happen for another 80 years! But the melting has accelerated.

American coastal cities are now planning to cope with oceans rising 3 to 15 feet (de-

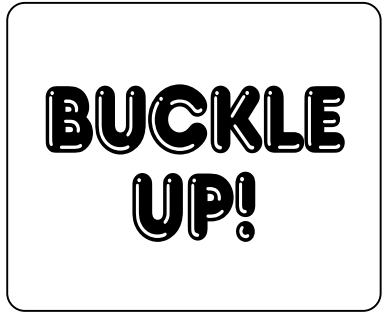

Dear EarthTalk: What is the Domestic Fuels Protection Act of 2012 and why are environmental groups opposing it? —William Bledsoe, Methuen, MA

THE DOMESTIC Fuels Protection Act of 2012 (H.R. 4345) is a bill that was introduced in the House of Representatives in April 2012 by a bi-partisan group of Congress members to protect domestic producers of ethanol, biodiesel and other green-friendly fuels from liability to end-users who put the wrong kind of fuel or fuel mix into their tanks and damage their engines and/or emit exaggerated amounts of pollution accordingly. The idea behind the bill is to ensure that domestic “green” fuel and related equipment producers aren’t forced into dire financial straits or put out of business due to crippling liability claims.

But some feel that the fuel industry, whether its products are environmentally friendly or not, should be held accountable for damage its products may cause.

Most recently, E15, a fuel blend containing 85 percent gasoline and 15 percent ethanol (a renewable crop-based fuel) came under fire for causing en-

gine damage in some older cars and trucks. The EPA approved the use of E15 in 2010 after lobbying from the ethanol industry, which seeks to up the ethanol content of gasoline from what had been the standard of 10 percent, which is much easier for gasoline engines to tolerate.

The Auto Alliance, an industry group, recently released a study claiming that upwards of five million cars on U.S. roads today could be damaged if owners pump in E15 instead of straight gasoline or even the milder E10 (10 percent ethanol, 90 percent gasoline). “Problems included damaged valves and valve seats, which can lead to loss of compression and power, diminished vehicle performance, misfires, engine damage, as well as poor fuel economy and increased emissions,” reports the group, adding that the potential costs to consumers are significant. “The most likely repair would be cylinder head replacement, which costs from \$2,000-4,000 for single cylinder head engines and twice as much for V-type engines.”

Environmental and consumer advocates say that H.R. 4345 is a bad deal for consumers who will be left footing the bill for these repairs. The non-profit Environ-

mental Working Group (EWG) bemoans the bill because it would exempt hugely profitable and already “favored interests” including fuel producers, engine makers and retailers of fuels and fuel additives from liability for damage caused by their products.

H.R. 4345 is currently under committee review in the House, but analysts doubt it will ever make it to a floor vote given the contentious debate surrounding the fact that it puts the burden of repair costs on end consumers. Users on the govtrack.us website (which provides free and comprehensive legislative tracking for everyday citizens) give H.R. 4345 only a three percent chance of passing. Meanwhile, the Senate is considering a companion bill, the so-called Domestic Fuels Act (S. 2264). But unless the House passes its version first, the Senate bill is unlikely to gain much traction.

Growth in Colo. agricultural exports up

ColoAgri 8/22)—Colorado’s agricultural exports increased by \$107.1 million or 18 percent to \$710.1 million in the first six months of 2012 over 2011, led by export increases in meats, dairy, wheat and dry beans, according to the Colorado Department of Agriculture.

“Colorado agriculture is the fabric of this state, with quality locally grown products sold from our local farmers markets to markets abroad, rich with opportunity,” said Colorado Agricultural Commissioner of Agriculture John Salazar. “We are enthused about the continued growth of Colorado’s agricultural exports to international markets which contribute to Colorado’s economic vitality.”

Colorado’s agricultural export increases were led by Colorado’s leading agricultural commodities.

- Meat exports increased by \$79 million or 22 percent.
- Dairy exports increased by \$14 million or 44 percent, more than doubling dairy exports since 2010.
- Vegetable (predominately dry edible beans) exports increased nearly \$10 million or 188 percent.

• Wheat exports increased by \$2 million, with growth primarily in the Mexican market.

Colorado’s top export markets continue to lead in agricultural exports.

• Exports to Canada increased 11 percent by \$19 million to \$191.9 million.

• Exports to Mexico increased 16 percent by \$21 million to \$149 million.

• Exports to Japan increased 48 percent by \$32 million to \$99.6 million.

• Exports to China increased 18 percent by \$9.8 million to \$63 million.

• Exports to Korea increased 6 percent by \$3 million to \$56.9 million.

• Exports to Russia increased 83 percent by \$13 million to \$28.7 million.

“Agricultural exports are often a major share of Colorado’s total exports to our key international markets,” said Salazar. “It is important that we continue to advocate for further access in global markets for our agricultural products. Colorado’s agricultural exports have further growth opportunities as we work to open and expand global markets.”

Colorado agricultural exports in the first six months of 2012 increased by \$194.2 million or 38 percent since the first six months of 2010.

• Colorado’s agricultural exports accounted for 17.9 percent of Colorado’s total exports.

• Colorado’s agricultural exports accounted for 19.8 percent of Colorado’s total exports to Canada.

• Colorado’s agricultural exports accounted for 35.7 percent of Colorado’s total exports to Mexico.

• Colorado’s agricultural exports accounted for 18.9 percent of Colorado’s total exports to China.

• Colorado’s agricultural exports accounted for 46 percent of Colorado’s total exports to Japan.

• Colorado’s agricultural exports accounted for 45.9 percent of Colorado’s total exports to Korea.

• Colorado’s agricultural exports accounted for 66 percent of Colorado’s total exports to Russia.
