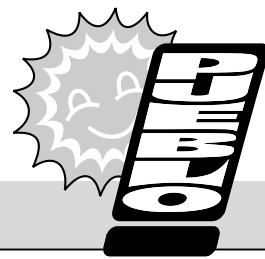

Entrepreneurial tilt on Feb. 27 at CSU-Pueblo to feature Jake Jabs

CSU-P 2/21) - The finale for the 2nd Annual Pueblo Entrepreneurship Competition, "One idea changes everything. What's yours?" will occur on Friday, Feb. 27 at the Sangre de Cristo Arts and Conference Center, 210 North Santa Fe Avenue, featuring keynote speaker Jake Jabs, President and CEO of American Furniture Warehouse. The Pueblo Entrepreneurship Competition is a collaborative, non-profit activity coordinated by the Colorado State University-Pueblo Hasan School of Business Healy Center, Junior Achievement, and PEDCO, made possible in part by a grant from the Southern Colorado Community Foundation.

As part of the day-long event, Jabs will conduct an afternoon session for high school and college students as well as a keynote address at 6:45 p.m. The event also will feature local celebrities and business leaders as judges and emcees. The competition seeks to encourage entrepreneurial thinking and action in Pueblo County.

According to Dr. Michael W. Wakefield, professor of management and director of the Thomas V. Healy Center for Economics and Business Research and Service in CSU-Pueblo's Hasan School of Business, the morning and afternoon events are free to students, but seating is limited.

This year, prizes will be offered in three divisions Kindergarten - 8th grade (\$500 top prize), High School (top prize is \$1,000 cash and a \$4,000 scholarship to HSB), and the Adult Venture Capital Competition. These sessions will begin at 8 a.m. for the Kindergarten-8th grade session, 9:45 a.m. for the high school session, and 7:30

p.m. for the adult competition. All student prizes, except the top high school prize, are sponsored by Southwest Motors. Thousands of dollars are available in the Adult Division with cash and cash-equivalent prizes offered by PEDCO and Little Caesar's. The adult portion of the competition resembles the "Shark Tank" television show, which will offer cash prizes in addition to up to \$1.5 million in venture capital funding by five angel investors to launch and expand outstanding business ideas.

In last year's inaugural competition, Cindy Dou won the high school student division, taking home \$1,000 cash and a \$4,000 scholarship to CSU-Pueblo's Hasan School of Business. Judy Kochevar netted \$1,500 offered by Pueblo Urban Renewal Association to expand her specialty business, The Hand Truck Company. Diana Hall won the \$3,500 Dave Feamster/Little Caesar's Pizza Social Entrepreneurship award and the PEDCO Foundation's \$5,000 office rental award to launch her business, 3DMedScan, which operates from the Business Technology Center Incubator at 3rd and Main. Her company has branched out from medical support devices such as casts to high-end golf accessories designed to improve a golfer's putting stroke.

The afternoon event is FREE for high school and university students, but tickets are required. To reserve tickets for the afternoon event, please contact Kim Wharton, 549-2142. Tickets to the evening event are \$7 and may be purchased through the Sangre de Cristo Arts Center Box Office, 295-7200.

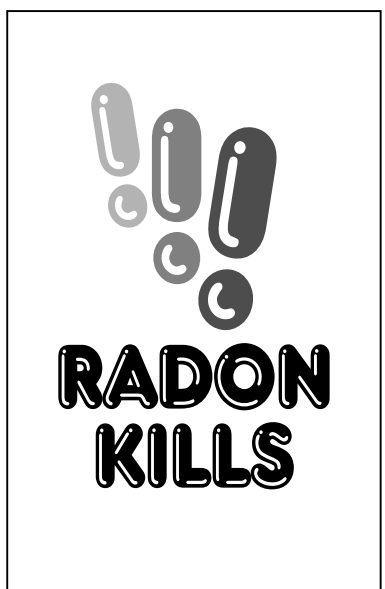

Colorado lecture series, The Chicano Movement Yesterday and Today, explores how *El Movimiento* shaped identity

DENVER, FEB. 20--The Chicano movement, or *El Movimiento*, paralleled the social movements of the 1960's, which awakened awareness among millions of Americans. Like Black Power, the Women's Movement, and the anti-war movement, Colorado's *El Movimiento* improved lives in ways that are still experienced today. This will be explored on Tuesday, Feb. 24, from 6:00 to 8:00 p.m., when History Colorado's FWD (Forward) lecture series will focus on "The Chicano Movement Yesterday and Today." The program takes place at the History Colorado Center at 1200 Broadway.

The event is part of *El Movimiento*: The Chicano Movement in Colorado. Created by museum staff along with community advisers from across Colorado, the exhibit opened on Feb. 7, along with the traveling exhibit, 1968. *El Movimiento* will be exhibited at the Colorado History Center through October 25.

The panel will be moderated by Ramon Del Castillo, Chair of the Chicana/o Studies Department at the Metropolitan State University of Denver. He has

been recognized not only in education but also as a researcher, journalist, author and poet. He is a past columnist of the Rocky Mountain News and present-day columnist for *El Seminario*.

Panelists include:

Tony Garcia, Executive Artistic Director of El Centro Su Teatro since 1989. He is an Affiliate Faculty member at the Metropolitan State University of Denver in the Chicana/Chicano Studies Department and was named the Denver Post 2010 Theatre Person of the Year.

Al Gurule, a nine-year member of Pueblo City Council and its president in 2001. He was a political activist in the late 1960s and 1970s, and ran as La Raza Unida Party candidate for governor of Colorado.

Shirley Romero, a native of San Luis, Colorado, and a descendant of the state's original Mexicano settlers. She is a long-standing Chicana activist and co-founder of the Land Rights Council in Chama, Colorado.

Nita Gonzales, M. Ed., president and CEO of Escuela Tlateloco, a national model for Chicano/Mexicano, and Indig-

enous education. A Denver native, the eldest daughter of Rodolfo "Corky" Gonzales and Geraldine Gonzales, she has been widely recognized for her work as a community builder and visionary.

Ricardo Rocha, a student at the Metropolitan State University of Denver, is an activist for the betterment of his community. He is a member of the Juvenile Justice Delinquency Prevention Advisory Council of Colorado.
