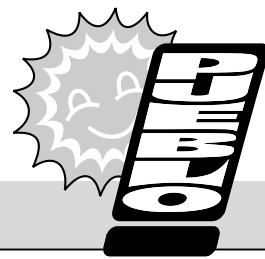

Tips for Eco-Friendly Mosquito Control

Don't let mosquitoes keep you from enjoying your garden and outdoor parties. Look for environmentally sound ways to manage these pests in your garden and landscape.

Start by eliminating standing water in the yard. Buckets, old tires and clogged gutters and downspouts that hold water make the perfect breeding ground for mosquitoes.

Drain water that collects in these as well as kids' toys, tarps and pool covers. Store these items in the garage or turn them over to keep them from becoming a mosquito breeding ground. Even small containers hold enough water for hundreds to thousands of mosquitoes to breed.

Change the water in birdbaths at least once a week. Consider installing a small pump to keep water moving to prevent mosquito breeding. Or use an organic mosquito control like Mosquito Dunks and Bits (SummitResponsibleSolutions.com) in rain barrels and water features. The Mosquito Bits quickly knock down the mosquito larval population, while the Mosquito Dunks provide 30 days of control. They are both certified organic and safe for pets, fish, wildlife and children.

Wear light colored, loose fitting clothing. These pests are less attracted to the lighter colors and can't readily reach your skin through loose clothing. And be sure to cover as much of your skin as possible with long sleeves and pants.

Add a few birdhouses to the landscape to bring in the birds. You'll enjoy their beauty and benefit from their diet of insects, including many garden pests and

mosquitoes.

Keep the garden weeded. Mosquitoes rest in shrubs, trees and weeds during the day. Removing weeds and managing neglected garden spaces will make your landscape less inviting to these pests.

Consider using a personal repellent to protect you against disease-carrying mosquitoes. For those looking to avoid DEET, the Center for Disease Control and Prevention has also approved products with the active ingredient picaridin (found in Skin so Soft products), IR3535, and the synthetic oil of lemon and eucalyptus. Avoid products that contain both sunscreen and insect repellents as you need to apply the sunscreen more often than the repellent.

Add a bit more protection while sitting or eating outdoors. Use a fan to create a gentle breeze that keeps the weak flying mosquitoes away from you and your guests. Some gardeners even take a small fan into the garden, while weeding.

Then add a bit of ambience to your next party by lighting a few citronella candles for your evening events. Citronella oil and the scented candles do have some mosquito repelling properties. Scatter lots of candles throughout your entertainment space. Position the candles within a few feet of your guests. This can provide some short term relief from these pests for you and your guests.

ColParksWild-Hasty, CO) - The wet Colorado spring at John Martin Reservoir has allowed something that hasn't been seen for quite a while: high water levels.

That means it's a great time to visit the park. There's plenty of room for boating in the reservoir that now spans roughly nine miles long and two miles wide. There's also 200-plus campsites and nearly five miles of hiking trails to explore.

Water levels at John Martin Reservoir are nearly seven times higher than levels last year. As of June 23, the reservoir had 276,000 acre feet of water, while last year at a similar time of year the reservoir held only around 30,000 acre feet.

Arkansas River below the dam at Lake Pueblo State Park now closed to inner tubers and some boats

ColParksWild 6/22—Colorado Parks and Wildlife has closed a portion of the Arkansas River, below the dam at Lake Pueblo State Park to tubers and non-whitewater boats. This closure does not include the upper Arkansas River through the Arkansas Headwaters Recreation Area (AHRA).
The closure applies to a one-mile section of the Arkansas

River, from Lake Pueblo State Park to Pueblo Blvd. All boaters and tubers, with the exception of whitewater canoes and kayaks, are prohibited until further notice.

"We issued a river advisory for the same section last year temporarily because of high flows and we feel that this year, the flows are at a level that require a complete closure of the stretch for the public's safety," said Lake Pueblo State Park Manager Monique Mullis.

The Arkansas River in the closed section is flowing over 6000 cubic feet per second (cfs), which is well above the average of 2200 cfs.

"River flows in this section are dynamic and can change daily depending on how much water the Bureau of Reclamation decides to release from Pueblo Reservoir at any given time," said Mullis. "With the water levels at the reservoir being so high, additional releases downstream are going to be necessary for several days."

The river section within the park will reopen for rafting, boating and tubing when water flows return to a safe level, said Mullis.

Colorado Parks and Wildlife would like to remind people spending time on the water this summer of the following safety tips:

1. Always wear a lifejacket
2. Never go on the water alone
3. Know your abilities and limitations and plan accordingly
4. Scout the river ahead of time for hazards (strainers, debris, dangerous conditions)
5. If you fall in the river, point your feet downstream and look for a point to get out. Never put your feet down and try to stand!
6. Get out of the water as soon as possible.
7. If you see someone fall in, use Reach, Throw and Go
8. Dress for the water temperature, not the air temperature
9. Take swim lessons
10. Keep your children within reach

CSU-Pueblo hosts Rocky Mountain Cooperative forensics camp in July

CSU-P 6/26) – Students from universities across the country will gather July 7-13 at Colorado State University-Pueblo to facilitate the growth and awareness of debate in the region and support the University's forensics program as part of the Rocky Mountain Cooperative (RMC).

Forensics Director Kathryn Starkey was approached early in the year by coaches in the debate community about hosting a summer camp to promote debate and provide an opportunity for students across the country to hone their parliamentary debate skills with experience levels ranging from first-year novice students to college seniors with several years of competition under their belts.

CSU-Pueblo recently revived its forensics program and is located in an area central to many schools in the region. Throughout the 1970s and 1980s, the University hosted a summer forensics workshop for high school and college students.

"Now that the team is back on campus, we are happy once again to offer a college debate camp," said Starkey. "Our goal

is to make the RMC an annual event to help provide an affordable and educational experience for students around the region and to reinvigorate the high school camp that reigned on this campus for years."

Participating students will attend more than a dozen lectures ranging from how to write a debate case to topic specific lectures on domestic and international issues and then participate in several practice debates to reinforce the topics learned in the daily lectures. All camp participants will compete in a round-robin style tournament from 8 a.m. to 7 p.m. on Sunday, July 12 in the Psychology Building. The public is invited to attend this event.

Registered attendees include students from Texas Tech University, University of Texas at Tyler, Casper College, Eastern Wyoming College, Colorado Christian University, Northwest College, CU Boulder, as well as the host CSU-Pueblo team. Coaches attending hail from Texas Tech, CSU-Pueblo, University of Montana, CU-Boulder, Stanford University, and Colorado College.
