Universal health care plan 2016 ballot question likely

ColoCareYes 10/23)—A citizens' group—ColoCareYes—promoting comprehensive health care for every Coloradan, delivered 156,107 signatures to the Secretary of State Friday morning, Oct. 23, which the organization believes should be far more than the 98,492 valid signatures needed to put Initiative #20 ColoradoCare on the ballot in 2016.

Amid much hoopla, signed and notarized petitions from every corner of Colorado arrived via ambulance to the office of the Secretary of State's office around 9 a.m. Friday at 1700 Broadway in Denver. A boisterous crowd was on hand at Denver's Civic Center Park afterward to celebrate the end of the highly successful petition drive.

Supporters in Fort Collins, Colorado Springs, and Grand Junction also planned celebrations Friday to mark the successful completion of the signature campaign.

"We've been overwhelmed with the number of people who agree that we should provide health care for every Coloradan," said Lyn Gullette, of Louisville, the campaign director. "And people realize that when Colorado makes it work, we can be a model for the whole USA."

ColoradoCare is a nonprofit health insurance plan that would cover every Coloradan up to age 65; seniors would keep Medicare as their primary insurance, and ColoradoCare would provide supplemental coverage. It would

be financed like the public schools. Everybody who earns income would pay for the system, and everybody's medical care would be covered.

The plan is based on legislation proposed by state Sen. Irene Aguilar, a Denver physician who is recognized as the leading health policy voice in the Colorado legislature.

"We tried to pass it in the legislature," Aguilar said. "But with the money in politics these days, there's no chance. Fortunately, in Colorado, if the legislature refuses to do what's needed, the people can vote it into law through a ballot initiative."

Denver author T. R. Reid, a leader of the citizens' campaign, noted that "ColoradoCare will be a Win/Win/Win for Coloradans. It will cover everybody; it will save billions in administrative costs; and it will get the state out of ObamaCare."

The federal Affordable Care Act, widely known as ObamaCare, has a specific waiver provision for states that don't want to be bound by the complex ObamaCare regulations. Under Sec. 1332 of the act, any state that provides health coverage better than ObamaCare can get a waiver from the federal system. ColoradoCare leaders believe its plan would qualify for this waiver.

"A vote for ColoradoCare," Reid noted, "will free us from legal mandates and penalties

imposed by Washington, D.C. But a vote against ColoradoCare is a vote for the status quo — that is, for ObamaCare. And ObamaCare leaves about 373,000 Coloradans with no health insurance at all.”

“We’re convinced that we can design a system right here in Colorado that’s better than anything Washington, D.C. wants to stick us with,” said former state Sen. Jeanne Nicholson, a public health nurse and a leader of the campaign. “The powerful response to our petition drive shows that people all over the state agree.”

More than 550 volunteers gathered signatures in nearly every county to give Coloradans the opportunity to vote for the plan next fall. Larimer County volunteer Eliza Carney, a veteran of previous ballot campaigns, said “I’ve never had such a positive response to a petition before.”

For state and local government, the annual savings are projected to be significant:

—The city and county of Denver would see savings of about \$52.1 million per year (52 percent) in health care costs if its employees could switch to ColoradoCare;

—Colorado Springs would save \$11.3 million or 52.6 percent;

—Larimer County would save \$8.9 million per year, about 60.7 percent; and Mesa County would save \$2 million, or 38.2 percent on employee health care costs.

Chip Bair of Idaho Springs, founder of the popular Beau Jo’s Pizza chain, said that the universal coverage plan would “be great for my employees, a boon for my business, and big boost for economic development. Businesses will flock to Colorado because they know all their employees will have great health coverage.”

The initiative says that Coloradans could still choose to buy private health insurance if they prefer, though ColoradoCare pays for more health care than even platinum plans on the exchange.

“ColoradoCare provides more

coverage for less money,” Nicholson said. “The administrative costs are going to be much lower than private insurance, so we can set the premiums lower as well.”

Private health insurers report that they spend about 20 percent of premium income on paperwork, marketing, executive salaries, etc. ColoradoCare has been designed to work like Medicare, where such administrative costs are less than 4 percent of premium income.

Beyond that, the plan would cover every primary care doctor, chiropractor, physical therapist, etc. “We are never going to use the “narrow network” gimmick that insurance companies have devised to limit patient choice,” Aguilar said. “It’s a basic principle of ColoradoCare that the patient—not the insurance company—should choose the doctor and the hospital.”

To date, Reid says, the only opposition to the plan has come from out-of-state investors who want to ensure soaring profits for the health insurance industry. A pressure group called “Americans for Prosperity,” based in Florida and financed by Kansas billionaires Charles and David Koch, has criticized ColoradoCare.

“It’s not surprising that out-of-state business tycoons are fighting this plan,” Reid said. “They are afraid that private insurers will have to cut their prices if they have to compete with ColoradoCare. And they’re right; this plan will reduce premiums for everybody.”

Reid sharply challenged the official wording of ColoradoCare, which describes the proposal as a tax increase. “If a family pays \$300 for ColoradoCare instead of \$500 for private insurance, that’s not a cost increase. It’s a big saving,” he said. “But the Secretary of State refuses to take into account how much everybody saves, so they call it an ‘increase.’”

Economic analyses cited by ColoradoCareYes predict that families and businesses would save some \$4.5 billion a year by adopting ColoradoCare to replace the insurance plans in place today.

Atty. Gen. Coffman joins 23 states challenging EPA authority

AttyGen 10/23) — On October 23, the Environmental Protection Agency (EPA) officially published in the Federal Register its 111(d) Rule, commonly referred to as the “Clean Power Plan.” The official publication of the rule has allowed Colorado, along with a bipartisan group of 23 other states, to formally challenge the rule in federal court. The legal challenge will clarify whether the EPA has authority under § 111(d) of the Clean Air Act to usurp the States’ control over their power grids, and to establish federal limits not just on existing power sources but on all carbon emissions from the States’ energy economies.

“The 111(d) rule is an attempt to expand federal power over the States through administrative regulation in violation of the law,” said Colorado Attorney General Cynthia H. Coffman. “Coloradans value the environment, and our state continues to be a national leader in establishing clean energy standards. We’ve proven again and again that good environmental policy can be developed and implemented successfully by Coloradans, and within the bounds of the law. This rule fits neither description.”

The case was filed today in the United States Court of Appeals for the District of Columbia.

As part of the suit, the bipartisan 24-state-coalition will ask that the court put the rule’s deadlines on hold. If that stay request is granted, states will have the option of waiting for a definitive court ruling before expending time and public resources on implementation of a rule that may be found invalid. The state plaintiffs also will seek an expedited court decision, whether or not the Clean Power Plan is stayed.

Seniors Face Higher Medicare Premiums, Deductibles Next Year

The last couple of weeks have brought unexpected and unwelcome news to millions of seniors and disabled people on Medicare. Their already high out-of-pocket costs are going to get higher. For some, premiums for Medicare Part B coverage that pays for doctor and outpatient services will go up as much as 52 percent. For everyone Part D premiums, which cover drug benefits, will increase an average of 13 percent, and everyone will see their annual Part B deductible rise from \$147 to \$223.

These are not trivial amounts considering that half of all people on Medicare are living on annual incomes of \$24,150 or less. In 2010 about 7 million people covered by the program lacked supplemental insurance such as Medigap policies, which cover what Medicare doesn’t. By 2013 the number of people without the additional coverage had more than doubled, most likely because they couldn’t afford to buy it.

What’s going on here? Weren’t Medicare’s costs supposed to go down thanks to the Affordable Care Act?

These increases have nothing to do with Obamacare and everything to do with the laws governing Medicare and Social Security.

Each year the Secretary of Health and Human Services examines the spending for Part B services which actually has risen this past year. By law premiums paid by everyone on Medicare must cover 25 percent of the program’s cost. (General tax revenues cover 75 percent.) And each year the Social Security Administration determines the cost-of-living increases (COLA) for seniors based on the Consumer Price Index. There will be no increase for the coming year.

All this means about 30 percent of beneficiaries will see increases for Part B. Most people have their premiums deducted from their Social Security checks, but the law prohibits any Part B premium increase that would result in a reduction in their Social Security benefits. Without a COLA increase, a higher premium means a smaller Social Security check.

Because Medicare premiums must cover 25 percent of Part B costs, the government has to find the money somewhere. So four groups of people will have to shoulder the added financial burden.

They include those who begin receiving Medicare benefits in 2016, those over age 65 who are on Medicare but who have not taken their Social Security benefits yet; wealthier beneficiaries (individuals with incomes above \$85,000 and

couples with \$170,000) and low-income people eligible for both Medicare and Medicaid. State Medicaid programs pay those increases and they, too, are grumbling.

Increases in Part D premiums stem from higher costs for both brand and generic prescriptions and particularly for specialty drugs like Sovaldi to treat hepatitis C.

Will Congress fix these inequities and find other funds to protect everyone from these increases? “It’s very hard to predict what Congress will do,” says Tricia Newman, senior vice president at the Kaiser Family Foundation. Newman points out this year’s higher premiums and deductibles may be temporary and are expected to come down in 2017.

The other day I explained all this on a New York City radio show along with Joe Baker who heads the Medicare Rights Center, which helps beneficiaries from all over the country understand their options. Callers on fixed incomes and tight budgets drove home the point: The increases will pinch. One woman told of a \$300 rent increase she had to absorb along with higher prices for food and medicines.

Another said her husband had cancer, and the family had been socked with high medical costs. She said they had to pay a \$3,000 deductible before insurance kicked in. Most likely she meant the requirement to pay \$3,000 out of pocket before her Medicare Advantage plan pays benefits. That’s a common out-of-pocket limit for these types of plans. Even if she didn’t label the source of the problem correctly, she knew the family budget was in trouble.

That led to a discussion of the how the COLA adjustment is calculated and whether it is fair to seniors because they spend money on a different market basket of goods than younger Americans do. They spend more on healthcare, for example, and less on gasoline, which is heavily factored into the cost-of-living calculations. But despite years of talk and experiments with a more accurate cost of living index for seniors, the government has yet to implement one.

Years ago healthcare expert Marilyn Moon, who served as a public trustee of the Social Security and Medicare Trust Funds, urged Americans to save their money because they were going to need it for medical care when they got older. This year’s situation shows how right she was.
