# Pueblo's Walter's Beer featured in 'Colo. Life' magazine

ColoLife 3/4)—The return of Pueblo's beloved Walter Brew-

ing Co. is celebrated in the latest issue of *Colorado Life Magazine*. The five-page article, "Resurrecting Walter's Beer," by Nathan Ward, which appears in *Colorado Life's* March/April issue, recounts the twists and turns in the saga of this hometown brew.

"Walter's Beer was the beverage that united Pueblo," Ward writes. "Pueblo was a mixing ground of cultures all mashed together to make steel in the mills; Walter's Beer was the re-

freshing common ground that helped bridge cultural gaps to form a community."

Starting with brewery's opening in 1898, the red-and-white Walter's Beer label became ubiquitous in Pueblo. When the brewery closed in 1975, a part of the regional identity was lost. However, a group of native Puebloans opened a new Walter Brewing Co. in 2014, bringing back the old lager recipe for a new generation, while also adding new craft

brews to the lineup.

The article appears in the current issue of *Colorado Life Magazine*. Through May 1, 2016, new subscribers who mention the code CPR22 will receive a complimentary copy of the Walter's Beer issue.
